RESOLUTION NO. 2015-061

AMENDING NAPOLCOM RESOLUTION NO. 2010-028 BY PRESCRIBING
THE NEW MINIMUM STANDARDS IN THE SPECIFICATIONS
FOR LAPTOP/NOTEBOOK COMPUTER

WHEREAS, Section 14, paragraphs (i) and (m) of Republic Act No. 6975, as amended by Section 5, paragraph (a), sub-paragraphs (5) and (8) of the Republic Act No. 8551, empowers the Commission to "approve or modify plans and programs on education and training, logistical requirements, communications, records, information system, crime laboratory, crime prevention and crime reporting as well as prescribe minimum standards for arms, equipment and uniforms and, after consultation with the Philippine Heraldry Commission, for insignia of ranks, awards and medals of honor";

WHEREAS, pursuant to the aforementioned legal prescription, the PNP, through the Uniform and Equipment Standardization Board (UESB) Resolution No. 2014-036 has proposed amendments to NAPOLCOM Resolution No. 2010-028, which prescribed the standard specifications for Laptop/Notebook for consideration and approval by the Commission as basis by the PNP to procure portable computers with the latest technology;

WHEREAS, after thorough review and evaluation, the proposed amendments to the specifications for Laptop/Notebook Computer are in order and in conformity with the requirement of Republic Act No. 6975 as amended by Republic Act No. 8551 the Government Procurement Act under RA No. 9481 and its Implementing Rules and Regulations (IRR), meet the requirements of the Philippine National Police;

NOW, THEREFORE, the Commission, in the exercise of its constitutional power to administer and control the PNP, HAS RESOLVED TO AMEND, AS IT HEREBY AMENDS NAPOLCOM Resolution No. 2010-028 by prescribing the new minimum standards in the specifications for Laptop/Notebook Computer, to read as follows:

I. TECHNICAL SPECIFICATIONS:

III. Must pass the PNP Test and Evaluation.


