RESOLUTION No. 2015 - 509 \_\_\_\_\_

**GRANTING THE CHIEF, PNP THE AUTHORITY TO FILL SIXTY-TWO (62) VACANCIES  
 FOR THE RANKS OF POLICE SENIOR INSPECTOR AND POLICE INSPECTOR VIA THE  
 PNP CY 2015 LATERAL ENTRY PROGRAM**

WHEREAS, Republic Act No. 6975, as amended, specifically Section 14 thereof, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, the Officer-In-Charge, PNP requested this Commission for authority to fill a total of sixty-two (62) vacancies for the ranks Police Senior Inspector and Police Inspector via the CY 2015 PNP Lateral Entry Program;

WHEREAS, the CY 2015 PNP Lateral Entry Program is aimed at recruiting the best and most qualified applicants for technical positions with the ranks of Police Senior Inspector and Police Inspector in the different PNP Technical Services;

WHEREAS, the sixty-two (62) vacancies for the CY 2015 PNP lateral entry program are broken down as follows:

WHEREAS, the quota distribution for Police Senior Inspector and Police Inspector ranks is broken down as follows:

WHEREAS, this Commission, after review of the PNP CY 2015 Lateral Entry Program, finds the same to be in order considering that the filling of such vacancies shall reduce the vacancies for the ranks of Police Senior Inspector and Police Inspector and shall address the PNP's requirement for Technical Service personnel;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the Philippine National Police, HAS RESOLVED TO GRANT, AS IT HEREBY GRANTS, the Chief, PNP the authority to fill sixty-two (62) vacancies for the ranks of Police Senior Inspector and Police Inspector via the PNP CY 2015 Lateral Entry Program.

PROVIDED, that the prescribed guidelines and procedures for the lateral entry of officers into the PNP under NAPOLCOM Memorandum Circular No. 2008-006 as amended by Memorandum Circular No. 2011-005 shall be strictly observed.

RESOLVED FINALLY, that the Chief of Office/Unit, members of the Lateral Entry Board and members of the Screening and Selection Committee, including the head and members of the Secretariat, who shall fail to strictly observe and comply with the rules and procedures and other pertinent policies and regulations on appointment of police personnel shall be dealt with under existing rules and regulations.
