RESOLUTION NO. 2015-510

EXPRESSING THE NATIONAL POLICE COMMISSION'S CONCURRENCE WITH THE PROPOSAL TO NAME THE ISABELA POLICE PROVINCIAL OFFICE AS "CAMP LT ROSAURO D TODA JR"

WHEREAS, the Constitution and Section 14 of Republic Act No. 6975, as amended, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, Section 25, RA 6975 provides that "x x x The PNP shall be composed of a national office, regional offices, provincial offices, district offices, city or municipal stations";

WHEREAS, at present, the PNP maintains eighty (80) Police Provincial Offices (PPOs) which correspond to the number of provinces nationwide, that includes Isabela PPO;

WHEREAS, the Isabela PPO is being considered to be named as "Camp Lt Rosauro D Toda Jr" in recognition of the officer's probity, dedication, resiliency and sacrifice in the service of the country;

WHEREAS, the "Revised Guidelines on the Naming and Renaming of Streets, Public Schools, Plazas, Buildings, Bridges and Other Public Structures" promulgated by the National Historical Commission of the Philippines (NHCP), provides that "National roads, schools, bridges, buildings, plazas and other structures can be renamed by the Office of the President or the Congress of the Philippines;

NOW, THEREFORE, the Commission, pursuant to its constitutional and statutory mandates, HEREBY RESOLVES TO CONCUR, AS IT HEREBY CONCURS, with the proposal to name the Isabela Police Provincial Office as "CAMP LT ROSAURO D TODA JR"

BE IT RESOLVED FURTHER, that a copy of this Resolution be furnished to the House of Representatives, Senate of the Philippines and the Office of the President (OP) for the enactment of a law or issuance of a directive from the OP naming the Isabela Police Provincial Office as "CAMP LT ROSAURO D TODA JR".
