RESOLUTION NO. 2015-589

APPROVING THE CANCELLATION OF NAPOLCOM RESOLUTION NO. 2003-046 THAT
PRESCRIBED THE MINIMUM STANDARD SPECIFICATIONS FOR EXPANDED
EXPLOSIVE AND ORDNANCE DISPOSAL (EEOD) TOOL KIT

WHEREAS, Section 14, paragraphs (i) and (m) of Republic Act No. 6975, as amended by Section 5, paragraph (a), sub-paragraphs (5) and (8) of the Republic Act No. 8551, empowers the Commission to “approve or modify plans and programs on education and training, logistical requirements, communications, records, information system, crime laboratory, crime prevention and crime reporting as well as prescribe minimum standards for arms, equipment and uniforms and, after consultation with the Philippine Heraldry Commission, for insignia of ranks, awards and medals of honor”;

WHEREAS, pursuant to the aforecited legal prescription, the PNP Uniform and Equipment Standardization Board (UESB) Resolution No. 2015-015 dated May 7, 2015 has recommended cancellation of NAPOLCOM Resolution No.2003-046, on the prescribed standard specifications for Expanded Explosives and Ordnance Disposal (EEOD) Tool Kit, for consideration and approval by the Commission;

WHEREAS, the items enumerated in the NAPOLCOM Resolution No. 2003-046 were deemed consumables and expendable items and/or small tangible asset as enumerated in the Commission on Audit Circular No. 2005-002 S. of 2005, Section 2.2.1;

NOW, THEREFORE, the Commission, in the exercise of its constitutional powers to administer and control the PNP, HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES the cancellation of NAPOLCOM Resolution No. 2003-046 that prescribed the Standard Specifications for Expanded Explosives and Ordnance Disposal (EEOD) Tool Kit on the ground that these are expendable/consumable and/or small tangible items enumerated in the COA Circular No. 2005-002 hence, no longer to require a NAPOLCOM Resolution to prescribe a specification.
