RESOLUTION NO. 2015-612

CLARIFYING THE RECKONING DATE IN THE COMPUTATION OF THE  
“EXPERIENCE” REQUIREMENT AS PROVIDED FOR UNDER THE QUALIFICATION  
STANDARDS FOR APPOINTMENT TO PNP RANKS

WHEREAS, the Constitution and Section 14 of Republic Act No. 6975, as amended, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, Section 19, RA 8551 provides that “All uniformed members of the PNP shall undergo a Field Training Program for twelve (12) months involving actual experience and assignment in patrol, traffic, and investigation as a requirement for permanency of their appointment”;

WHEREAS, during the abovementioned period, police recruits undergo the mandatory training on Public Safety Basic Recruit Course (PSBRC) for PO1, while lateral entrants undergo training on Public Safety Officers’ Basic Course (PSOBC);


WHEREAS, police recruits and lateral entrants are issued temporary appointments while undergoing their respective mandatory one (1) year training and subsequently issued permanent appointment after completion of the training;

WHEREAS, the experience requirement under the qualification standard for appointment to PNP ranks is the number of years wherein a police officer has been appointed to a particular rank;


WHEREAS, there is a conflicting/contradictory interpretation as to the reckoning date in the computation of said “experience” requirement;

NOW, THEREFORE, the Commission, pursuant to its constitutional and statutory mandates, HEREBY RESOLVES TO CLARIFY, AS IT HEREBY CLARIFIES, that the computation of the “Experience” requirement as provided for under the qualification standards for appointment to PNP ranks shall be reckoned from the date of signing of the appointment by the appointing authority of *Komisyon ng Serbisyo Sibil (KSS) Porma Bilang 33*, whether such appointment is permanent or temporary.
