RESOLUTION NO. 2016-144

PRESCRIBING THE MINIMUM STANDARD SPECIFICATIONS
FOR HAND GRENADE, FRAGMENTATION

WHEREAS, Section 14, paragraphs (i) and (m) of Republic Act No. 6975, as amended by Section 5, paragraph (a), sub-paragraphs (5) and (8) of the Republic Act No. 8551, empowers the Commission to “approve or modify plans and programs on education and training, logistical requirements, communications, records, information system, crime laboratory, crime prevention and crime reporting as well as prescribe minimum standards for arms, equipment and uniforms and, after consultation with the Philippine Heraldry Commission, for insignia of ranks, awards and medals of honor”;

WHEREAS, pursuant to the aforesaid legal prescription, PNP, Uniform and Equipment Standardization Board (UESB) Resolution No. 2015-024 dated 05 August 2015, recommended to the Commission for approval of the proposed standard specifications for Hand Grenade, Fragmentation;

WHEREAS, the subject specification seeks to intended to acquire an anti-personnel weapon designed to explode small particles of projectiles or fragments upon detonation to supplement suppressive small arms fire against enemies in close quarter combat;

WHEREAS, the proposed specifications for Hand Grenade, Fragmentation is certified by the PNP being a not tailored fit specification to any particular brand of product available in the open market;

WHEREAS, the Commission has determined it to be in conformity with Republic Act No. 6975, as amended by Republic Act No. 8551, its Implementing Rules and Regulations (IRR), and all existing policies and issuances of the Commission to meet the requirements of the PNP;

NOW THEREFORE, the Commission in the exercise of its statutory power to administer and control the PNP, RESOLVED AS IT HEREBY RESOLVES TO PRESCRIBE the minimum standard specifications for Hand Grenade, Fragmentation, with slight modification, to read as follows:

I. TECHNICAL SPECIFICATIONS

A. Technical Data

 - 3) Detonator : Based on Manufacturer's Brochure Specifications Submitted
- C. Dimension
 - 1) Length : Based on Manufacturer's Brochure Specifications Submitted
 - 2) Diameter : Based on Manufacturer's Brochure Specifications Submitted
- D. Performance
 - 1) Delay Time : 3-5.5 seconds
 - 2) Casualty Radius : 15 meters
 - 3) Fatality Radius : 5 meters
- E. Must pass the PNP Test and Evaluation
