CONFERMENT OF THE PNP DISTINGUISHED CONDUCT MEDAL (MEDALYA NG KABAYANIHAN) TO THE THEN PSSUPT FERNANDO H MENDEZ JR AND PSSUPT EDGAR S MONSALVE


WHEREAS, Section 14 (m) of R.A. No. 6975, as amended by R.A. 8551, and NAPOLCOM Memorandum Circular No. 93-018, as amended by NAPOLCOM Memorandum Circular Nos. 2006-003 and 2010-004, dated November 30, 2006 and October 27, 2010, respectively, prescribe the authorized decorations, service medals, ribbons and badges of the Philippine National Police (PNP);

WHEREAS, the Chief, PNP, through the Special Promotions, Awards and Decorations Board (SPADB) Resolution No. 16-68, dated November 28, 2016, hereby recommends the reclassification of award from PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod) to PNP Distinguished Conduct Medal (Medalya ng Kabayanihan) to the then PSSUPT Fernando H Mendez Jr and PSSUPT Edgar S Monsalve, for their conspicuous acts of courage and heroism in the face of enemy as case supervisor/agent supervisor and as case officer/agent handler, respectively, of the intelligence package used for the neutralization of Zulkifli Bin Hir a.k.a. Marwan;


WHEREAS, after reviewing the facts of the case, the Commission finds merit on the proposed conferment of the PNP Distinguished Conduct Medal (Medalya ng Kabayanihan) to the then PSSUPT Fernando H Mendez Jr and PSSUPT Edgar S Monsalve;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO CONFER, AS IT HEREBY CONFERS**, the PNP Distinguished Conduct Medal (Medalya ng Kabayanihan) to the then PSSUPT Fernando H Mendez Jr and PSSUPT Edgar S Monsalve.
