RESOLUTION NO. 2017-044

INDORSING THE RECOMMENDATION OF THE CHIEF, PNP TO THE PROVINCIAL GOVERNOR OF MOUNTAIN PROVINCE, FOR THE DESIGNATION OF THE PROVINCIAL DIRECTOR, MOUNTAIN PROVINCE POLICE PROVINCIAL OFFICE, PRO COR FROM THE LIST OF ELIGIBLE POLICE COMMISSIONED OFFICERS

WHEREAS, pursuant to Republic Act No. 6975, specifically Section 51(a)(1) and b(i)(4) thereof, the Provincial Governors and City Mayors have the authority to choose the Provincial Director and Chief of Police within their respective jurisdictions from a list of eligibles recommended by the PNP Regional Director:

WHEREAS, under NAPOLCOM Resolution No. 2002-078, no placement, assignment, reassignment or promotion involving PNP senior officers to key positions shall be effected without personnel action passing through the Senior Officers Placement and Promotion Board (SOPPB);

WHEREAS, the Chief, PNP, acting upon Resolution No. 2016-608 of the SOPPB, dated December 5, 2016, recommended any of the following for possible designation as Provincial Director, Mountain Province Police Provincial Office (PPO), Police Provincial Office (PRO) COR;




WHEREAS, the Chief, PNP certified that these police senior officers satisfy all the requirements for designation to a key position in the PNP;
