RESOLUTION NO. 2017-053

**INDORSING THE RECOMMENDATION OF THE CHIEF, PNP TO THE CITY MAYOR
OF ZAMBOANGA, FOR THE DESIGNATION OF THE CITY DIRECTOR,
ZAMBOANGA CITY POLICE OFFICE, PRO 9, FROM THE LIST OF
ELIGIBLE POLICE COMMISSIONED OFFICERS (PCOs)**

WHEREAS, pursuant to Republic Act No. 6975, specifically Section 51(a)(1) and b(i)(4) thereof, the Provincial Governors and City Mayors have the authority to choose the Provincial Director and Chief of Police within their respective jurisdictions from a list of eligibles recommended by the PNP Regional Director:

WHEREAS, under NAPOLCOM Resolution No. 2002-078, no placement, assignment, reassignment or promotion involving PNP senior officers to key positions shall be effected without personnel action passing through the Senior Officers Placement and Promotion Board (SOPPB);

WHEREAS, the Chief, PNP, acting upon Resolution No. 2016-610 of the SOPPB, dated December 5, 2016, recommended any of the following for possible designation as City Director, Zamboanga City Police Office (CPO), Police Regional Office (PRO) 9;




