RESOLUTION NO. 2017-103

REVOKING THE SPECIAL PROMOTION OF PO1 ROEL O ARMECIN UNDER NAPOLCOM RESOLUTION NO. 2014-311 DATED 18 SEPTEMBER 2014

WHEREAS, under Section 38 (b) of Republic Act 6975, as amended by Section 33 (b) of R.A. 8551, special promotion may be granted to any member of the Philippine National Police for acts of conspicuous courage and gallantry at the risk of his/her life above and beyond the call of duty;

WHEREAS, the then Chief, PNP, PDG Alan La Madrid Purisima, recommended the granting of Medalya ng Kabayanihan (PNP Distinguished Conduct Medal) to PO1 Roel O Armecin through the Special Promotion, Awards and Decorations Board (SPADB) Resolution No. 14-72, dated March 25, 2014;

WHEREAS, a validation report from the Inspection, Monitoring and Investigation Service (IMIS), this Commission, recommended the confirming of special promotion to PO1 Armecin instead of Medalya ng Kabayanihan (PNP Distinguished Conduct Medal) by virtue of the Commission's inherent power of administrative control and supervision over the PNP as provided under Section 14 of Republic Act 6975, as amended by R.A. 8551;

WHEREAS, the Legal Affairs Service, this Commission, made its position clear on the matter, upon the request of then Commissioner Luisito T. Palmera, questioning the confirmation of special promotion to PO1 Armecin, where in fact a validation must only be made by the Commission on recommendations for special promotion and not on the granting of Medalya ng Kabayanihan (PNP Distinguished Conduct Medal):

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO REVOKE, AS IT HEREBY REVOKES**, the special promotion of PO1 Roel O Armecin under NAPOLCOM Resolution No. 2014-311, dated September 18, 2014.
