RESOLUTION NO. 2017-115

**CONFIRMING THE RANK ADJUSTMENT ORDERS OF SPO4 EDGARDO R PEDROSA
AND SPO1 DANTE T CHING PREVIOUSLY APPROVED BY THE PNP**

WHEREAS, the Commission issued Resolution No. 2008-176 dated March 18, 2008, the last issuance that confirmed the rank adjustment orders of seven hundred seventy (770) PNP personnel previously approved by the PNP and who were not able to meet the March 31, 2005 deadline provided under NAPOLCOM Resolution No. 2005-042;

WHEREAS, the PNP appealed to the Commission for the confirmation of additional six hundred twenty-six (626) rank adjustment orders of PNP personnel who were not able to meet the March 31, 2005 deadline and were not included in the confirmation of rank adjustment orders under NAPOLCOM Resolution No. 2008-176, and further requested another three hundred thirty-eight (338), for a total of nine hundred sixty-four (964) unconfirmed PNP personnel;

WHEREAS, the PNP, in a meeting with the Commission on June 20, 2013, requested for the confirmation of rank adjustment of an additional eight hundred fifty-two (852) PNP uniformed personnel for the last and final instance;

WHEREAS, the PNP rationalized that the confirmation of rank adjustment orders of the concerned PNP personnel would make their appointment permanent in status and therefore, qualify them for promotion;


WHEREAS, it was also agreed that the list of PNP personnel whose rank adjustment orders are for confirmation shall be submitted in batches in order to facilitate the processing of the total rank adjustment orders;

WHEREAS, the PNP, in view of the aforesaid agreement, submitted to the Commission the documentary requirements of SPO4 EDGARDO R PEDROSA and SPO1 DANTE T CHING with unconfirmed rank adjustment orders, the fourteenth (14th) batch of applicants who completed the required documents;

WHEREAS, the Commission finds the documentary requirements of SPO4 EDGARDO R PEDROSA and SPO1 DANTE T CHING to be in order;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO CONFIRM, AS IT HEREBY CONFIRMS**, the rank adjustment orders of SPO4 Edgardo R Pedrosa and SPO1 Dante T Ching
