RESOLUTION NO. 2017-167

AMENDING NAPOLCOM RESOLUTION NO. 2010-311, ENTITLED: "APPROVING THE RESTRUCTURING OF THE OFFICE OF THE DEPUTY CHIEF, PHILIPPINE NATIONAL POLICE (PNP) FOR OPERATIONS"

WHEREAS, the Commission issued NAPOLCOM Resolution No. 2010-311, entitled: "*Approving the Restructuring of the Office of the Deputy Chief, Philippine National Police for Operations*" as provided for under NHQ-PNP General Order No. DPL-10-04, which states the powers, functions and composition of the Office of the Deputy Chief, PNP for Operations (ODCO);

WHEREAS, the PNP submitted for consideration of the NAPOLCOM a copy of NHQ-PNP General Order No. DPL-16-16, which provides for the "Restructuring of the Office of the Deputy Chief, PNP for Operations (ODCO)" amending NHQ-PNP General Order No. DPL-10-04;

WHEREAS, the proposed restructuring of the ODCO is aimed at ensuring its adaptability to relevant standards and practices, streamlining workflow processes and effectively and efficiently achieving its mandated functions with the least number of office personnel;

WHEREAS, the proposed ODCO shall be restructured with an Administrative and Security Unit and a Special Concerns Management Unit which shall have a human resource complement of ten (10) uniformed and eight (8) non-uniformed personnel (NUP), respectively;

WHEREAS, the existing NUP positions under the ODCO shall be reclassified to position titles with higher salary grades commensurate to their stature with greater accountabilities and responsibilities being under the Command Group of the PNP;


WHEREAS, after evaluation of the restructuring of the ODCO, the Commission finds the same to be in order considering that it is aimed at improving organizational efficiency;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the proposed restructuring of the Office of the Deputy Chief, PNP for Operations.


RESOLVED, FURTHER, that NHQ-PNP General Order No. DPL-16-16 which provides for the restructuring of the ODCO shall form part of this Resolution.




