RESOLUTION NO. 2017-188

CONFERMENT OF THE PNP DISTINGUISHED SERVICE MEDAL (MEDALYA NG KATAPATAN SA PAGLILINGKOD) TO PCSUPT REUBEN THEODORE CASENAS SINDAC

WHEREAS, Section 14 (m) of R.A. No. 6975, as amended by R.A. 8551, and NAPOLCOM Memorandum Circular No. 93-018, as amended by NAPOLCOM Memorandum Circular Nos. 2006-003 and 2010-004, dated November 30, 2006 and October 27, 2010, respectively, prescribe the authorized decorations, service medals, ribbons and badges of the Philippine National Police (PNP);

WHEREAS, PDG Ronald M Dela Rosa, Chief, PNP, through the Special Promotions, Awards and Decorations Board (SPADB) Resolution No. 16-86, dated December 28, 2016, hereby recommends the conferment of the PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod) to PCSUPT Reuben Theodore Casenas Sindac for his exceptional performance during his tenure as Director, Logistics Support Service (LSS) from October 2, 2014 to December 19, 2016, where he efficiently supervised the procurement and distribution of essential logistical requirements needed to strengthen the PNP's capabilities and sustain its mission to maintain peace and order;


