RESOLUTION NO. 2017-199

INDORSING THE RECOMMENDATION OF THE CHIEF, PNP TO THE PROVINCIAL GOVERNOR OF LANA DEL SUR, FOR THE DESIGNATION OF THE PROVINCIAL DIRECTOR, LANA DEL SUR POLICE PROVINCIAL OFFICE, PRO ARMM FROM THE LIST OF ELIGIBLE POLICE COMMISSIONED OFFICERS

WHEREAS, pursuant to Republic Act No. 6975, specifically Section 51(a)(1) and b(i)(4) thereof, the Provincial Governors and City Mayors have the authority to choose the Provincial Director and Chief of Police within their respective jurisdictions from a list of eligibles recommended by the PNP Regional Director:

WHEREAS, under NAPOLCOM Resolution No. 2002-078, no placement, assignment, reassignment or promotion involving PNP senior officers to key positions shall be effected without personnel action passing through the Senior Officers Placement and Promotion Board (SOPPB);

WHEREAS, the Chief, PNP, acting upon Resolution No. 2017-020 of the SOPPB, dated January 27, 2017, recommended any of the following for possible designation as Provincial Director, Lanao del Sur Police Provincial Office (PPO), Police Provincial Office (PRO) ARMM;



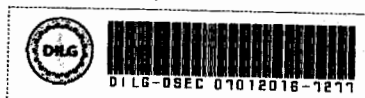
