RESOLUTION NO. 2017-240

**CONFIRMING THE SPECIAL PROMOTION PCINSP GILZEN NINO REGIS MANESE
AND TWO (2) OTHERS**

WHEREAS, under Section 38 (b) of Republic Act 6975, as amended by Section 33 (b) of R.A. 8551, special promotion may be granted to any member of the Philippine National Police for acts of conspicuous courage and gallantry at the risk of his/her life above and beyond the call of duty;


WHEREAS, PDG Ronald M Dela Rosa, Chief, PNP recommended PCINSP Gilzen Nino Regis Manese, PO2 Celso Maratas Pilonos Jr and PO1 Marvin Lungtad Salonga for a Special Promotion through the Special Promotion, Awards and Decorations Board (SPADB) Resolution No. 16-46, dated September 9, 2016, for their display of conspicuous courage and gallantry in action above and beyond the call of duty during a police operation about a reported shooting and robbery hold-up incident that transpired on March 6, 2015 at Loremae Restaurant located in Brgy. Militar and pursued at the National Highway, Brgy. Camanga, Tukuran, Zamboanga del Sur, against a robbery hold-up group known as "Baylon Group," where PCINSP Manese and his team, although outnumbered, engaged the group in a firefight that resulted in the death of three (3), wounding of two (2), and arrest of three (3) robbery hold-up suspects;

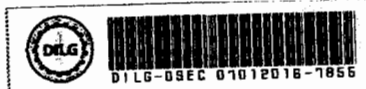
