RESOLUTION NO. 2017-251

**CONFERMENT OF THE PNP DISTINGUISHED SERVICE MEDAL (MEDALYA NG
KATAPATAN SA PAGLILINGKOD) TO PDIR FEDERICO P CASTRO JR
AND THREE (3) OTHERS**

WHEREAS, Section 14 (m) of R.A. No. 6975, as amended by R.A. 8551, and NAPOLCOM Memorandum Circular No. 93-018, as amended by NAPOLCOM Memorandum Circular Nos. 2006-003 and 2010-004, dated November 30, 2006 and October 27, 2010, respectively, prescribe the authorized decorations, service medals, ribbons and badges of the Philippine National Police (PNP);

WHEREAS, PDG Ronald M Dela Rosa, Chief, PNP, through the Special Promotion, Awards and Decorations Board (SPADB) Resolution Nos. 17-08, 17-09, 17-10, 17-11 and 17-12, all dated January 30, 2017, hereby recommends the conferment of the PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod) to PDIR Federico P Castro Jr and three (3) others;

WHEREAS, PDIR Federico P Castro Jr is being conferred of said medal for his invaluable services rendered to the defunct Philippine Constabulary/Integrated National Police (PC/INP) and to the Philippine National Police (PNP) from April 10, 1978 to February 25, 2017, or a total of thirty-eight (38) years, ten (10) months and fifteen (15) days;

WHEREAS, PDIR Castro Jr is also being conferred of said medal for his exceptional performance of major responsibility as Acting Director, Directorate for Integrated Police Operations-Southern Luzon from November 9, 2015 to January 19, 2016 and as Director from January 20, 2016 to February 25, 2017;

WHEREAS, PCSUPT Abad H Osit is being conferred of said medal for his invaluable services rendered to the defunct PC/INP and to the PNP from September 20, 1982 to February 23, 2017, or a total of thirty-four (34) years, five (5) months and three (3) days;

WHEREAS, PCSUPT Nestor F Quinsay Jr is being conferred of said medal for his invaluable services rendered to the defunct PC/INP and to the PNP from April 10, 1978 to February 25, 2017, or a total of thirty-eight (38) years, eleven (11) months and seven (7) days;



WHEREAS, PCSUPT Valfrie G Tabian is being conferred of said medal for his invaluable services rendered to the defunct PC/INP and to the PNP from April 1, 1982 to February 24, 2017, or a total of thirty-four (34) years, ten (10) months and twenty-three (23) days;


