RESOLUTION No. 2017 - 258

APPROVING THE UPGRADING OF THE COMPOSTELA MUNICIPAL POLICE STATION (MPS) UNDER COMPOSTELA VALLEY POLICE PROVINCIAL OFFICE, POLICE REGIONAL OFFICE NO. 11, FROM A TYPE "B" INTO A TYPE "A" MPS

WHEREAS, Section 14 of Republic Act No. 6975, as amended, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, the PNP submitted for consideration of the Commission a copy of NHQ-PNP General Order Number DPL-17-01 which provides for the upgrading of Compostela Municipal Police Station (MPS) under Compostela Valley Police Provincial Office, Police Regional Office No. 11, from a Type "B" to a Type "A" MPS;

WHEREAS, based on the records obtained by the PNP from the Philippine Statistics Authority (PSA) and the Department of Finance (DOF), Compostela Municipality has a population of 87,474 based on the 2015 PSA Census and a 1st Class Income Classification based on DOF Order No. 23-08;


WHEREAS, NAPOLCOM Resolution No. 2005-140, entitled: *"Resolution Amending Sections "E", "G" and "H" of NAPOLCOM Resolution No. 92-036 entitled 'Approving the Revised Organizational Structure of the Philippine National Police and Providing Policies and Guidelines in the Implementation Thereof,'* provides for the parameters in the categorization/classification of police offices and stations wherein a Type "A" MPS should have a town population of 85,000 and above and should be a 1st to 3rd Class Income Classification;

WHEREAS, the Commission finds merit in the upgrading of the classification of Compostela Municipal Police Station from a Type "B" to a Type "A" as it conforms with the parameters provided under NAPOLCOM Resolution No. 2005-140;


NOW THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the upgrading of the Compostela Municipal Police Station (MPS) under Compostela Valley Police Provincial Office, Police Regional Office No. 11, from a Type "B" to a Type "A" MPS.

RESOLVED, FURTHER, that NHQ-PNP General Order Number DPL-17-01 shall form part of this Resolution.
