RESOLUTION NO. 2017-300

APPROVING THE PLACEMENT OF ISABELA COMPONENT CITY POLICE STATION UNDER THE ADMINISTRATIVE SUPERVISION AND OPERATIONAL CONTROL OF THE REGIONAL DIRECTOR, POLICE REGIONAL OFFICE 9

WHEREAS, Section 14 of Republic Act No. 6975, as amended, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, Section 25 (paragraph 2), RA No. 6975, provides that *“The PNP shall be composed of a national office, regional offices, provincial offices, district offices and city or municipal stations”*;

WHEREAS, the Isabela Component City Police Station, pursuant to PNP-NHQ General Order Number DPL-02-04, dated March 15, 2002, was placed under the administrative control of the Regional Director, Police Regional Office 9 (PRO 9), while operational control over it was vested to the Regional Director, Police Regional Office Autonomous Region in Muslim Mindanao (PROARMM);

WHEREAS, the Sangguniang Panlungsod of the City of Isabela, through its Resolution No. 16-5205, is now requesting that both the administrative and operational supervision of Isabela CCPS be given to PRO 9;


WHEREAS, the said organizational lines of authority and supervision constitute a departure from management standard and the principle of “unity of command”;


WHEREAS, the PNP, in its desire to rectify such dysfunction, deemed it necessary that the administrative supervision and operational control over the Isabela Component City Police Station be vested exclusively to the Regional Director, PRO 9;


WHEREAS, the NAPOLCOM, after a review of the proposal, finds the same to be in order;


NOW, THEREFORE, the NAPOLCOM, pursuant to its constitutional and statutory mandates, **HEREBY RESOLVES TO APPROVE, AS IT HEREBY APPROVES**, the placement of Isabela Component City Police Station under the administrative supervision and operational control of the Regional Director, PRO 9.


