RESOLUTION NO. 2017-308

CONFERMENT OF THE PNP DISTINGUISHED SERVICE MEDAL (MEDALYA NG KATAPATAN SA PAGLILINGKOD) TO PDDG FRANCISCO ALLAGA UYAMI JR


WHEREAS, Section 14 (m) of R.A. No. 6975, as amended by R.A. 8551, and NAPOLCOM Memorandum Circular No. 93-018, as amended by NAPOLCOM Memorandum Circular Nos. 2006-003 and 2010-004, dated November 30, 2006 and October 27, 2010, respectively, prescribe the authorized decorations, service medals, ribbons and badges of the Philippine National Police (PNP);


WHEREAS, PDG Ronald M Dela Rosa, Chief, PNP, through the Special Promotions, Awards and Decorations Board (SPADB) Resolution No. 17-23, dated March 2, 2017, hereby recommends the conferment of the PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod) to PDDG Francisco Allaga Uyami Jr for his exceptional performance of major responsibility during his tenure as the Acting Deputy Chief for Administration (TADCA) of the Philippine National Police from July 1 to 9, 2016 and in full capacity as the Deputy Chief for Administration (TDCA) from July 10, 2016 to March 19, 2017. As second in command in the PNP hierarchy, PDDG Uyami Jr manifested competence, professionalism, and devotion to his sworn duties in the implementation of effective policing strategies specifically on police administration. He also ensured that the PNP delivers the finest public safety services and ably respond to the growing challenges of law enforcement and peacekeeping;

WHEREAS, after reviewing all the facts, the Commission finds merit on the proposed conferment of the PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod) to PDDG Francisco Allaga Uyami Jr;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO CONFER, AS IT HEREBY CONFERS**, the PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod) to PDDG Francisco Allaga Uyami Jr.
