RESOLUTION NO. 2017-309

**CONFERMENT OF THE PNP DISTINGUISHED SERVICE MEDAL (MEDALYA NG KATAPATAN SA PAGLILINGKOD) TO PDIR RENE DIAZ ONG**

**WHEREAS**, Section 14 (m) of R.A. No. 6975, as amended by R.A. 8551, and NAPOLCOM Memorandum Circular No. 93-018, as amended by NAPOLCOM Memorandum Circular Nos. 2006-003 and 2010-004, dated November 30, 2006 and October 27, 2010, respectively, prescribe the authorized decorations, service medals, ribbons and badges of the Philippine National Police (PNP);

**WHEREAS**, PDG Ronald M Dela Rosa, Chief, PNP, through the Special Promotions, Awards and Decorations Board (SPADB) Resolution No. 17-24, dated March 2, 2017, hereby recommends the conferment of the PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod) to PDIR Rene Diaz Ong for his exceptional performance of major responsibility during his tenure as Officer-in-Charge, Directorate for Research and Development (DRD) from December 18, 2015 to January 9, 2016, Acting Director from January 10, 2016 to March 8, 2016 and in full capacity as the Director from March 9, 2016 to March 23, 2017. PDIR Ong efficiently and effectively performed his tasks in assisting the Chief, PNP in the conduct of research and development tests and evaluation of clothing, materiel, vehicles, and equipment required by the PNP and in the formulation and implementation of the PNP Self Reliant and Development Program;

**WHEREAS**, after reviewing all the facts, the Commission finds merit on the proposed conferment of the PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod) to PDIR Rene Diaz Ong;

**NOW, THEREFORE**, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO CONFER, AS IT HEREBY CONFERS**, the **PNP Distinguished Service Medal (Medalya ng Katapatan sa Paglilingkod)** to PDIR Rene Diaz Ong.
