RESOLUTION NO. 2017-386

**CONFIRMING THE ACTIVATION OF DAVAO OCCIDENTAL
PROVINCIAL PUBLIC SAFETY COMPANY**

WHEREAS, Section 14 of Republic Act No. 6975, as amended, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, Executive Order No. 546 series of 2006 directed the PNP to support the Armed Forces of the Philippines (AFP) in internal security operations (ISO) for the suppression of insurgency and other serious threats to national security;

WHEREAS, said directive authorized the PNP to make appropriate adjustments in its organization subject to the approval of the NAPOLCOM;

WHEREAS, the NAPOLCOM issued Resolution No. 2010-154 entitled "Approving the Guidelines and Procedures for the Rationalization of the PNP Mobile Groups" aimed at making the PNP Mobile Groups more effective in discharging its functions and in consonance with the active role of the PNP under said Executive Order;

WHEREAS, relative thereto, the PNP submitted for confirmation of the Commission a copy of NHQ-PNP General Order Number DPL-17-09, which provides for the activation of the Davao Occidental Provincial Public Safety Company (PPSC);

WHEREAS, the PPSC proposed to be activated shall be under the administrative supervision and operational control of the Provincial Director, Davao Occidental Police Provincial Office (PPO), Police Regional Office 11 (PRO11);

WHEREAS, the Davao Occidental PPSC shall conduct internal security and counter-terrorism operations; respond to crisis situation extending beyond the capabilities of the police stations, and conduct rescue and relief operations within the province;


WHEREAS, the Davao Occidental PPSC shall be headed by a Police Commissioned Officer (PCO) with the rank of Police Superintendent;

WHEREAS, after review of the proposal, the Commission finds the same to be in order;


NOW, THEREFORE, the Commission, pursuant to its constitutional and statutory mandates, **HEREBY RESOLVES TO CONFIRM, AS IT HEREBY CONFIRMS**, the activation of the Davao Occidental Provincial Public Safety Company.

RESOLVED, FURTHER, that NHQ-PNP General Order Number DPL-17-09 which provides for the activation the Davao Occidental PPSC shall form part of this Resolution.
