RESOLUTION NO. 2017-421

CONFIRMING THE SPECIAL PROMOTION OF PINSP BOB T BELVER


WHEREAS, under Section 38 (b) of Republic Act 6975, as amended by Section 33 (b) of R.A. 8551, special promotion may be granted to any member of the Philippine National Police for acts of conspicuous courage and gallantry at the risk of his/her life above and beyond the call of duty;

WHEREAS, PDG Ronald M Dela Rosa, Chief, PNP recommended PINSP Bob T Belder for a Special Promotion through the Special Promotion, Awards and Decorations Board (SPADB) Resolution No. 16-74, dated December 5, 2016, for his display of conspicuous courage and gallantry in action, at the risk of his life above and beyond the call of duty, during a robbery-holdup incident at around 1:00 in the morning of September 2, 2015, while he was about to alight from a passenger bus at Alabang Viaduct, Alabang, Muntinlupa City, when four (4) unidentified suspects, armed with knives, approached him, declared holdup and grabbed his bag. Subject PCO introduced himself as a police officer and ordered the suspects to drop their knives and return his bag. However, instead of adhering to his order, two (2) of the suspects responded, "Walang pulis-pulis samini!" then proceeded to attack and stab him repeatedly, luckily missing the police officer, that prompted PINSP Belder to draw his firearm and shoot the suspects hitting two (2) of them on their legs. The suspects then fled thereafter, three (3) of them were subsequently arrested by the responding elements from Muntinlupa City Police Station. PINSP Belder's actions led to the arrest of the three (3) suspects and the recovery of two (2) kitchen knives, cellular phones, pistol magazines, one (1) flashlight and assorted clothes. A case of Robbery was filed against the suspects before Regional Trial Court Branch 276 at Muntinlupa City docketed under Criminal Case No. 15-1195;

WHEREAS, after reviewing the facts of the case, the Commission finds merit on the proposed Special Promotion of PINSP Bob T Belder in accordance with the provisions of Section 33 (b) R.A. 8551;

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO CONFIRM, AS IT HEREBY CONFIRMS**, the special promotion of **PINSP BOB T BELVER** to the next higher rank.
