RESOLUTION NO. 2017-440

APPROVING THE DISBURSEMENT OF A PORTION OF PAMAYANANG DIEGO SILANG'S  
SPECIAL ACCOUNT FUND FOR USE IN THE ACQUISITION OF ASSETS FOR THE  
BENEFIT OF NAPOLCOM

WHEREAS, the May 14, and 18, 1999 Memoranda of Agreement (MOA) executed by and between the National Police Commission (NAPOLCOM) and the Bases Conversion and Development Authority (BCDA) had provided, among others, a total of Two Thousand and Two Hundred Fifty (2,250) condominium housing units at the Pamayanang Diego Silang (PDS) in Taguig City, Metro Manila which were awarded to deserving and qualified officials and personnel of the NAPOLCOM and the Philippine National Police (PNP);

WHEREAS, the said MOAs also stipulated the creation of a Special Account Fund to serve as repository of all collections of amortizations derived from the sale of the 2,250 condominium housing units at PDS which shall be utilized by the Commission in the acquisition of assets for the benefit of NAPOLCOM and for its priority estate development projects;

WHEREAS, the Commission has an appropriation of P2,800,000.00 from the 2017 GAA for the procurement of Mini Bus;

WHEREAS, the public bidding held for the procurement of Mini Bus was declared failure of bidding due to non-submission of bid proposals by prospective bidders, thus, a mandatory review was undertaken which revealed that the Approved Budget for the Contract (ABC) is not sufficient since the market price of a Mini Bus is P3,700,000.00, more or less;


WHEREAS, as of December 31, 2016, the NAPOLCOM Special Account has a total outstanding balance of Four Million Four Hundred Eighty-Eight Thousand Five Hundred Seventy-Eight Pesos and Forty-Seven Centavos (PhP4,488,578.47) that can be utilized by the Commission;

WHEREAS, the NAPOLCOM Housing Board, pursuant to its Resolution No. 2017-05-01, recommended the utilization of One Million Pesos (PhP1,000,000.00) portion of the NAPOLCOM Special Account Fund to supplement the needed funds for the above-cited project;


NOW THEREFORE, THE COMMISSION RESOLVES, AS IT HEREBY RESOLVED, to authorize Bases Conversion and Development Authority to disburse and release One Million


Pesos (PhP1,000,000.00) portion of the NAPOLCOM Special Account Fund to supplement the needed funds for the procurement of a Mini Bus for the benefit of NAPOLCOM.
