**RESOLUTION NO. 2017-554**

**APPROVING THE PNP TABLE OF EQUIPMENT AND ALLOWANCES FOR  
THE OFFICE OF THE CHIEF, PHILIPPINE NATIONAL POLICE**

**WHEREAS**, Sections 28 and 85 of Republic Act No. 6975, provide, among others, the approval of the Table of Organization and Equipment of all Bureaus and Offices created under this Act;

**WHEREAS**, the Commission, in the exercise of its functions, finds the existing PNP Table of Equipment and Allowances (TEAs) for the Office of the Chief, PNP, embodied in NAPOLCOM Resolution No. 2009-479 dated September 1, 2009, as no longer responsive to the present requirements considering that most prescribed equipment were already deemed obsolete, in terms of quality and capability;

**WHEREAS**, after series of conferences and consultations with the different PNP Offices/Units which the Directorate for Logistics spearheaded, the proposed amendment to the PNP TEAs for the Office of the Chief, PNP was submitted based on the attached table;

**WHEREAS**, the functions of the Office of the Chief, PNP are as follows:

- a) Enforce all laws and ordinance relative to the protection of lives and properties;
- b) Maintain peace and order and take all necessary steps to ensure public safety;
- c) Investigate and prevent crimes, effect the arrest of criminal offenders, bring offenders to justice and assist in their prosecution;
- d) Exercise the general powers to make arrest, search and seizure in accordance with the constitution and pertinent laws;
- e) Detain an arrested person for a period not beyond what is prescribed by law, informing the person so detained of all his rights under the constitution;
- f) Issue licenses for the possession of firearms and explosives in accordance with law;
- g) Supervise and control the training and operation of security agencies and issue licenses to operate security agencies, and to security guards and private detectives for the practice of their professions; and
- h) Perform other duties and exercise all other functions as may be provided by law.

**WHEREAS**, the Office of the Chief PNP has assumed supervision over the following Special Units, such as:

- a) Center for Police Strategy Management (CPSM) - Annex "A"
- b) Human Rights Affairs Office (HRAO) - Annex "B"
- c) Internal Affairs Service (IAS) - Annex "C"
- d) Chief Executive Senior Police Officer (CESPO) - Annex "D"


WHEREAS, after thorough review and evaluation, the Commission finds the Table of Equipment and Allowances for the Office of the Chief, Philippine National Police in order and in conformity with Republic Act. No. 6975, as amended by Republic Act No. 8551, its implementing rules and regulations (IRR), and all existing policies/issuances of the Commission to meet the requirements of the PNP;

NOW, THEREFORE, the Commission in the exercise of its statutory powers to administer and control the PNP HAS RESOLVED, AS IT HEREBY RESOLVES, to approve the PNP Table of Equipment and Allowances for the Office of the Chief, Philippine National Police with the attached table consisting of four (4) pages and Annexes "A", "B", "C" and "D";

BE IT RESOLVED FURTHER, that all other existing PNP TEAs for the Office of the Chief, Philippine National Police, which are found inconsistent herewith are hereby cancelled/repealed.
