**RESOLUTION NO. 2017-597**

**APPROVING THE NEW TABLE OF EQUIPMENT AND ALLOWANCES  
FOR THE PNP DIRECTORATE FOR INTEGRATED POLICE OPERATIONS  
NORTHERN LUZON**

**WHEREAS**, Section 25 and 28 of RA No. 6975, provides, among others, the approval of the Table of Organization and Equipment of all Bureaus and Offices created under this Act;

**WHEREAS**, pursuant to the aforesaid legal prescription, the Commission issued NAPOLCOM Resolution No. 414 dated July 24, 2009 which confirmed the different Directorates for Integrated Police Operations (DIPOs) as per General Order No. DPL-09-11 which provides for the conversion of the status of the different DIPOs from provisional into regular directorates of the PNP including the revised organizational structure, staffing pattern and functions of the DIPOs;

**WHEREAS**, the NAPOLCOM Memorandum Circular No. 2008-11 dated June 16, 2008 directed the Chief, PNP to create a National TEA Revision Committee to undertake the revision/amendment of the approved PNP Table of Equipment and Allowances (TEA) that will help the formulation of individual office/unit/station logistical requirements based on the approved Table of Organization;

**WHEREAS**, the PNP National TEA Revision Committee undertook the formulation of a new PNP TEA for the DIPO Northern Luzon with the attached matrix table;


**WHEREAS**, the PNP DIPO Northern Luzon mission is “to direct and supervise the conduct of inter-regional anti-criminality, internal security and counter-terrorism operations which transcends regional boundaries and to provide system for delivery of police services contributory to the promotion of regional socio-economic development in Regions 1, 2, 3 and Cordillera”;

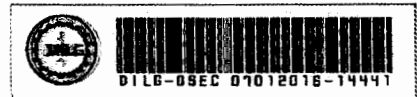
**WHEREAS**, after thorough review and evaluation, the Commission finds the proposed Table of Equipment and Allowances (TEA) for DIPO Northern Luzon in conformity with the requirements of Republic Act No. 6975, as amended by Republic Act No. 8551, its Implementing Rules and Regulations (IRR), all existing policies and issuances of the Commission to meet the requirements of the PNP;


**NOW THEREFORE**, the Commission in the exercise of its constitutional power to administer and control the PNP, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the PNP Table of Equipment and Allowances for DIPO Northern Luzon with the attached matrix table.

**BE IT RESOLVED FURTHER**, that all other issuances, rules and regulations which are inconsistent with the provisions of this policy are hereby repealed, amended or modified accordingly.
