RESOLUTION NO. 2018-026

GRANTING THE CHIEF, PNP, THE AUTHORITY TO FILL THE ONE THOUSAND FOUR HUNDRED NINETY-ONE (1,491) VACANCIES TO BE USED FOR THE PROMOTION OF PNP UNIFORMED PERSONNEL WHO PASSED THE NAPOLCOM SPECIAL PROMOTIONAL EXAMINATION ON JULY 30, 2017

WHEREAS, Republic Act No. 6975, as amended, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, based on the records of the PNP, out of the two thousand six hundred ninety-five (2,695) PNP uniformed personnel candidates for attrition due to non-promotion who took the NAPOLCOM Special Promotional Examination, only one thousand four hundred ninety-seven (1,497) passed;

WHEREAS, the passers of the NAPOLCOM Special Promotional Examination will be promoted under the CY 2017 Regular Promotion Program, thus, a separate quota which shall be deducted from the approved quota for the CY 2017 Regular Promotion Program, will be allocated exclusively for them;

WHEREAS, the number of personnel, by rank, who will undergo the special quota promotion process are as follows:

WHEREAS, NAPOLCOM Resolution 2013-501 dated October 23, 2013, entitled "Prescribing the Qualification Standards for Appointment to PNP Ranks," as promulgated by CSC Resolution No. 1401222 dated August 18, 2014 and NAPOLCOM Resolution No. 2016-069 dated January 28, 2016, entitled "Addendum to NAPOLCOM Resolution No. 2013-501, Entitled: Prescribing the Qualification Standards for Appointment to PNP Ranks," as promulgated by CSC Resolution No. 1600532 dated May 26, 2016, shall be the bases in determining the minimum qualification standards of the promotes;



(Granting the Chief, PNP the Authority to Fill 1,491 Vacancies to be Used for the Promotion of the PNP Uniformed Personnel who Passed the NAPOLCOM Special Promotional Examination on July 30, 2017)

NOW, THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO GRANT, AS IT HEREBY GRANTS**, the Chief, Philippine National Police, the authority to fill the one thousand four hundred ninety-one (1,491) vacancies to be used for the promotion on the PNP uniformed personnel who passed the NAPOLCOM Special Promotional Examination on July 30, 2017.



RESOLVED, FURTHER, that any amendment to this approved special quota shall be submitted to the Commission for approval;

RESOLVED, FINALLY, that the Chairman, Vice-Chairman and Members of the Promotion Board, including the Head and Members of the Secretariat, who shall fail to strictly observe and comply with the rules and regulations on selection and appointment of PNP uniformed personnel shall be dealt with under existing rules and regulations.
