**RESOLUTION No. - 2018-257**

**APPROVING THE RESTRUCTURING OF THE PNP  
GENERAL HOSPITAL (PNPGH) UNDER THE PNP HEALTH SERVICE**

**WHEREAS**, the Constitution and Republic Act No. 6975, as amended by Republic Act No. 8551, placed the Philippine National Police (PNP) under the administrative control and operational supervision of the National Police Commission (NAPOLCOM);

**WHEREAS**, the PNP submitted for approval of the Commission a copy of NHQ-PNP General Orders Number DPL-17-21 which provides for the restructuring of the PNP General Hospital (PNPGH) under the PNP Health Service;

**WHEREAS**, the proposed restructuring of the PNPGH is based on the standards set by the Department of Budget and Management and the Department of Health under the Revised Organizational Structure and Staffing Pattern for Government Hospitals;

**WHEREAS**, the PNPGH, as proposed, shall be headed by a Police Commissioned Officer with the prescribed rank of Police Senior Superintendent and shall maintain three functional staffs, namely: a) Medical Services Division; b) Nursing Services Division; and c) Hospital Administration Division;


**WHEREAS**, the Commission, after review of the PNP's submission, finds the same to be in order considering that it shall further enhance the effectiveness and efficiency of PNPGH in providing treatment and control of medical/surgical diseases, injuries, and deficiencies among PNP personnel, their dependents, and authorized civilians;

**NOW THEREFORE**, the Commission, in the exercise of its administrative control and operational supervision over the Philippine National Police, **HAS RESOLVED, AS IT HEREBY RESOLVES**, to approve the restructuring of the PNP General Hospital (PNPGH) under the PNP Health Service.


**RESOLVED, FURTHER**, that NHQ-PNP General Orders Number DPL-17-21 which provides for the organizational structure and staffing pattern of the PNPGH shall form part of this Resolution.
