RESOLUTION NO. 2018-361

**PROVIDING FOR A LEVEL OF PASSING FOR THE SPECIAL PNP ENTRANCE AND PROMOTIONAL EXAMINATIONS CONDUCTED ON MAY 27, 2018**

**WHEREAS**, Section 21 of Republic Act No. 8551, otherwise known as the "PNP Reform and Reorganization Act of 1998," which amended Section 32 of RA 6975, provides that the National Police Commission shall administer the entrance and promotional examination for policemen on the basis of the standards set by the Commission;

**WHEREAS**, in compliance with the foregoing mandate, the Commission conducts twice a year the PNP Entrance and Promotional Examinations;

**WHEREAS**, under Section 28 of RA 8551, any PNP personnel who has not been promoted for a continuous period of ten (10) years shall be retired or separated;

**WHEREAS**, the Chief, PNP, in his desire to help those PNP personnel who are candidates for attrition for not having been promoted for a continuous period of ten (10) years due to their failure to comply with the eligibility requirements, has requested through the Director for Personnel and Records Management (DPRM), for a Special Promotional Examinations to the PNP personnel who failed in the July 30, 2017 NAPOLCOM Special Promotional Examinations and to those PO1 personnel who are college graduates in temporary status, to take the Police Entrance Examination to give them better chance of passing the eligibility exam;

**WHEREAS**, the Commission finds the request of the Chief, PNP through The Director for Personnel and Records Management (DPRM) commendable as it will help the PNP personnel who are candidates for attrition to possess the appropriate police eligibility for promotion in the service;


**WHEREAS**, the Commission conducted the Special PNP Entrance and Promotional Examinations exclusively to all PNP uniformed personnel who are college graduates and candidates for attrition by non-promotion on May 27, 2018 in three (3) selected testing venues in NCR namely PNP Training Service at the PNP NHQ, Camp Crame, Quezon City, Camp Crame Elementary and High School and Camp Aquinaldo High School, Quezon City;

WHEREAS, the Commission, being considerate in the years of service rendered by these police officers, and in fulfilling their duties despite of not being promoted, extended opportunity to the PNP officers subject for attrition to be promoted by lowering the level of passing for the Special PNP Entrance and Promotional Examinations particularly for Police Inspector, Senior Police Officer, Police Officer and PNP Entrance examinations;


NOW THEREFORE, the Commission, in the exercise of its Constitutional mandate to administer and control the PNP, HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES the levels of passing for the Special PNP Promotional Examinations conducted on May 27, 2018 for each of the following examination categories:




