RESOLUTION NO. 2018-436

**RESOLUTION AMENDING NAPOLCOM RESOLUTION NO. 2018-281
ENTITLED: "APPROVING THE RESTRUCTURING AND
STRENGTHENING OF THE PNP CRIME LABORATORY"**

WHEREAS, Section 14 of Republic Act No. 6975, as amended, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, the PNP submitted for approval of the Commission a copy of NHQ-PNP General Order Number DPL-17-04 which provides for the restructuring and strengthening of the PNP's Crime Laboratory (CRIMELAB);

WHEREAS, the Commission approved the NHQ-PNP General Order No. DPL-17-10 thru NAPOLCOM Resolution No. 2018-28 entitled: "Approving the Restructuring and Strengthening of the PNP Crime Laboratory" which shall maintain two (2) Support Staffs: a) Administrative and Resource Management Division; and b) Operations Management Division which shall be both headed by Police Commissioned Officers (PCOs) with the rank Police Senior Superintendent;


WHEREAS, item no. 3 in the fourth (4th) WHEREAS of said Resolution, the rank of the heads of said Divisions was inadvertently specified as Police Superintendent;

WHEREAS, there is a need to rectify such provision in NAPOLCOM Resolution No. 2018-281 considering that the appropriate rank for Division Chief position in the PNP is Police Senior Superintendent;


NOW, THEREFORE, the Commission, pursuant to its constitutional and statutory mandates to administer and control the PNP, **HAS RESOLVED, AS IT IS HEREBY RESOLVES**, to amend NAPOLCOM Resolution No. 2018-281 specifically item no.3 in the 4th WHEREAS thereof, to read as follows:


***"3. The PNP CRIMELAB shall maintain two (2) Support staffs:
a) Administrative and Resource Management Division;
and b) Operations Management Division. The said
divisions shall be headed by Police Commissioned
Officers (PCOs) with the rank of Police Senior
Superintendent".***
