RESOLUTION NO. 2018-767

**GRANTING THE CHIEF, PHILIPPINE NATIONAL POLICE (PNP) THE AUTHORITY
TO PROMOTE SEVEN HUNDRED SIXTY-FIVE (765) UNIFORMED PERSONNEL
WHO PASSED THE NAPOLCOM SPECIAL QUALIFYING EXAMINATIONS**

WHEREAS, the Constitution and Republic Act (R.A.) No. 6975, as amended by Republic Act No. 8551, placed the Philippine National Police (PNP) under the administrative control and operational supervision of the National Police Commission (NAPOLCOM);

WHEREAS, the Commission conducted Special PNP Qualifying Examinations on August 7, 2016, July 30, 2017 and May 27, 2018 for the purpose of giving PNP uniformed personnel the opportunity to acquire the required eligibility for promotion so as not to be subjected to attrition due to non-promotion;

WHEREAS, the PNP originally requested authority from the Commission to promote one thousand seventy-six (1,076) uniformed personnel who passed the aforesaid NAPOLCOM Special Qualifying Examinations;

WHEREAS, after validation, it was determined by the PNP Directorate for Personnel and Records Management (DPRM) that the actual number of PNP uniformed personnel who are qualified and eligible for promotion, was only seven hundred sixty-five (765), as follows;

WHEREAS, the Commission, after review of the PNP's proposal, finds the same to be in order considering that the promotion of the concerned PNP uniformed personnel shall fulfill the main purpose of the Special Qualifying Examinations;

NOW THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the Philippine National Police, **HAS RESOLVED TO GRANT, AS IT HEREBY GRANTS**, the Chief, PNP the authority to promote seven hundred sixty-five (765) uniformed personnel who passed the NAPOLCOM Special Qualifying Examinations and have satisfied all the other requisites for regular promotion;

RESOLVED, FURTHER, that said quota for promotion shall be exclusive to those who passed the Special Qualifying Examinations and that any amendment thereof shall be submitted to the Commission for approval;




RESOLVED FINALLY, that the PNP shall formulate the necessary promotion program to implement the aforesaid promotional quota.
