RESOLUTION No. - 2019-048

**UPGRADING THE CLASSIFICATION OF SIX (6) MUNICIPAL POLICE STATIONS
UNDER POLICE REGIONAL OFFICE 5**

WHEREAS, the Constitution and Republic Act No. 6975, as amended by Republic Act No. 8551, placed the Philippine National Police (PNP) under the administrative control and operational supervision of the National Police Commission (NAPOLCOM);

WHEREAS, the PNP submitted for consideration of the Commission a copy of NHQ-PNP General Order Number DPL-18-19 which provides for the upgrading of the classification of six (6) Municipal Police Stations (MPS) under Police Regional Office 5, to wit:

Province	Municipality	Census 2015 Population	Income Class	Type
1. Masbate	Aroroy MPS	86,168	1 st Class	B to A
2. Masbate	Mandaon MPS	41,262	3 rd Class	C to B
3. Camarines Norte	Basud MPS	41,017	3 rd Class	C to B
4. Camarines Sur	Pili MPS	89,545	1 st Class	B to A
5. Sorsogon	Matnog MPS	41,101	3 rd Class	C to B
6. Albay	Polangui MPS	88,221	1 st Class	B to A

WHEREAS, under Section H of NAPOLCOM Resolution No. 2005-140, entitled: *“Resolution Amending Sections “E”, “G” and “H” of NAPOLCOM Resolution No. 92-036, entitled: “Approving the Revised Organizational Structure of the Philippine National Police and Providing Policies and Guidelines in the Implementation Thereof,”* the classification of MPS shall be in accordance with the following parameters:

1. Type “A” with a town population of 85,000 and above and 1st to 3rd Class Income Classification
2. Type “B”
 - a. With a town population of 85,000 and above, and 4th to 6th Class Income Classification; and
 - b. With a town population of 40,000 to less than 85,000, and 1st to 3rd Class Income Classification

WHEREAS, the Commission finds merit in upgrading the classification of the aforementioned Municipal Police Stations considering that they have satisfied the required population as well as the required municipal income classification prescribed under Section H of NAPOLCOM Resolution No. 2005-140;

NOW THEREFORE, the Commission, in the exercise of its administrative control and operational supervision over the Philippine National Police, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the upgrading of the classification of six (6) Municipal Police Station (MPS) under Police Regional Office 5.


RESOLVED FURTHER, that NHQ-PNP General Orders Number DPL-18-19 shall form part of this Resolution .




