RESOLUTION No. - 2019-1032

**APPROVING THE RESTRUCTURING AND STRENGTHENING OF
20 CITY POLICE OFFICES**

WHEREAS, the Constitution and Republic Act No. 6975, as amended by Republic Act No. 8551, placed the Philippine National Police (PNP) under the administrative control and operational supervision of the National Police Commission (NAPOLCOM);

WHEREAS, the PNP submitted for approval of the Commission a copy of NHQ-PNP General Orders Number DPL-18-25 which provides for the restructuring and strengthening of 20 City Police Offices (CPOs);

WHEREAS, the said PNP proposal includes, among others, the following salient provisions:

- a. Adoption of standard template for the organization and staffing patterns of all CPOs (except for the NUP complement of 5 newly upgraded CPOs namely: Santiago CPO under PRO2; Puerto Princesa CPO under PRO 4B; Naga CPO under PRO5; Lapu-Lapu CPO under PRO7; and Tacloban CPO under PRO8 which shall be subject to the approval by the DBM);
- b. Provision for additional 335 NUP positions for all CPOs;
- c. Creation of two (2) Support Staffs: (a) Administrative and Resource Management Unit (ARMU), and Plans and Strategy Management Unit (PSMU);
- d. Renaming of the Police-Community Relations Unit (PCRU) as "Community Affairs and Development Unit" (CADU); and
- e. Identification of 15,277 uniformed personnel positions for 20 City Police Offices (excluding 3, 549 uniformed personnel positions under the CPO Mobile Force Companies) and 795 NUP positions. The additional 335 NUP positions intended for all CPOs shall be submitted for approval by the DBM.

WHEREAS, the Commission, after review of the PNP's proposal, finds the same to be in order considering that said restructuring and strengthening of the 20 CPOs will further enhance the capability of the lower PNP units;

NOW THEREFORE, the Commission, in the exercise of its administrative control and operational supervision over the Philippine National Police, **HAS RESOLVED, AS IT HEREBY RESOLVES**, to approve the restructuring and strengthening of 20 CPOs.


RESOLVED, FURTHER, that NHQ-PNP General Orders Number DPL-18-25 which provides for the standard organizational structure and staffing pattern of the 20 CPOs be approved and adopted.

All other issuances or any part thereof which are inconsistent herewith are hereby repealed or modified accordingly.
