**RESOLUTION NO. 2019-135**

**APPROVING THE PHILIPPINE NATIONAL POLICE (PNP)  
 PROMOTION QUOTA FOR CALENDAR YEAR 2019**

**WHEREAS**, the Constitution and Republic Act No. 6975, as amended by Republic Act No. 8551, placed the Philippine National Police (PNP) under the administrative control and operational supervision of the National Police Commission (NAPOLCOM);

**WHEREAS**, the PNP submitted for approval of the Commission the promotion quota for calendar year (CY) 2019 consisting of 80,819 regular promotions and 2,072 special/meritorious promotions:

**WHEREAS**, the PNP based the computation of the promotion quota for C.Y. 2019 on the following:

- a. CY 2018 PNP Rank Distribution
- b. Directorate for Personnel and Records Management (DPRM) Projected Personnel Fill-up (December 30, 2018)
- c. Directorate for Plans (DPL) Initial Projected Rank Distribution for CY 2019 (Based on Identified Positions, Restructuring and Strengthening of Units)
- d. Allowance for Special/Meritorious Promotion (2.5% of the DPL initial quota for regular promotion for CY 2019)
- e. DPL Projected Quota for Regular Promotion 2019 (Resulting Vacancies)

**WHEREAS**, the filling-up of the promotion quota for CY 2019 aims to enhance the efficiency and effectiveness of the PNP organization by selecting and appointing qualified Police Commissioned Officers and Police Non-Commissioned Officers to the next higher rank through merit and fitness, and facilitate the upward movement of personnel in order to stabilize the PNP pyramidal structure;

**WHEREAS**, the Commission, after review of the PNP's proposal, finds the same to be in order;

**NOW THEREFORE**, the Commission, pursuant to its constitutional mandate to administer and control the Philippine National Police, **HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the PNP Promotion Quota for CY 2019.

**RESOLVED, FURTHER**, that any amendment to said promotion quota shall be submitted to the Commission for approval;


**RESOLVED FURTHERMORE**, that the Qualification Standards for appointment to PNP ranks under NAPOLCOM Resolution No. 2013-501 shall be observed;

**RESOLVED FINALLY**, that the PNP shall formulate the necessary promotion program to implement the aforesaid promotion quota.
