**RESOLUTION No. 2019-149**

**APPROVING THE ACTIVATION OF THE INTEGRITY MONITORING AND ENFORCEMENT GROUP (IMEG) AS A NATIONAL OPERATIONAL SUPPORT UNIT (NOSU) OF THE PHILIPPINE NATIONAL POLICE**

**WHEREAS**, the Constitution and Republic Act (R.A.) No. 6975, as amended by Republic Act No. 8551, placed the Philippine National Police (PNP) under the administrative control and operational supervision of the National Police Commission (NAPOLCOM);

**WHEREAS**, the PNP activated the Counter-Intelligence Task Force (CITF) on February 3, 2017 pursuant to NHQ-PNP Command Memorandum Circular No. 04-2017 in order to police its ranks and implement internal cleansing efforts;

**WHEREAS**, in view of the positive results of the CITF's accomplishments, the PNP deems it necessary to establish a regular National Operational Support Unit (NOSU) in order to sustain the internal cleansing efforts in its organization;

**WHEREAS**, the PNP submitted for consideration of the Commission a copy of NHQ-PNP General Orders Number DPL-18-06 (Corrected Copy), entitled: "Activation of Unit (Integrity Monitoring and Enforcement Group)";

**WHEREAS**, the IMEG shall perform the following functions:

- a. Receive complaints and information against erring personnel and conduct relevant information gathering activities;
- b. Detect and conduct intelligence build-up on the involvement of PNP personnel in illegal activities, acts of graft and corruption and other crimes for the conduct of prompt counter measures;
- c. Initiate law enforcement operations against rogue PNP personnel;
- d. Prepare and update watchlist of undesirable PNP personnel;
- e. Prepare and submit special and other relevant reports regarding undesirable PNP personnel;
- f. Conduct Personnel Security Investigations to include threat assessment, complete and partial background investigation to erring PNP personnel in coordination and collaboration with the Regional Intelligence Divisions, PROs and other concerned Units; and
- g. Perform other tasks as directed by the Chief, PNP.

**WHEREAS**, the IMEG shall maintain five (5) Divisions and three (3) Field Units to be headed by the following Police Commissioned Officers, to wit:

1. Administrative and Resource Management Division (ARMD)	Police Senior Superintendent (PSSupt)
2. Intelligence Division (ID)	PSSupt
3. Operations Management and Plans Division (OMPD)	PSSupt
4. Investigation and Detection Division (IDD)	PSSupt
5. Legal Division (LD)	PSSupt

<b>Field Units</b>	<b>Rank of the Chief</b>
1. IMEG-Luzon Field Unit	PSSupt
2. IMEG-Visayas Field Unit	PSSupt
3. IMEG-Mindanao Field Unit	PSSupt

WHEREAS, the IMEG shall be headed by a Director with the rank of Police Senior Superintendent and shall have a complement of three hundred six (306) uniformed personnel;

WHEREAS, three (3) uniformed personnel from the PNP Legal Service and a Company from the PNP Special Action Force shall be temporarily reassigned with the IMEG, which shall act as the IMEG's tactical component and placed under the operational control of the Director, IMEG;

WHEREAS, the Commission, after consideration of the PNP's proposal, finds the same to be in order considering that the activation of the IMEG will institutionalize in the PNP an operating arm that would police its ranks and maintain the organization's integrity;

NOW THEREFORE, the Commission, pursuant to its constitutional mandate to administer and control the PNP, HAS RESOLVED TO APPROVE, AS IT HEREBY APPROVES, the activation of the Integrity Monitoring and Enforcement Group (IMEG) as a National Operational Support Unit (NOSU) of the Philippine National Police (PNP).


RESOLVED FURTHER, upon approval of the activation of the IMEG, that the Counter-Intelligence Task Force shall be deactivated and its human resource, equipment, vehicles, records, funds and other resources be transferred to IMEG.

RESOLVED FURTHERMORE, that the attached NHQ-PNP General Orders Number DPL-18-06 (Corrected Copy) and its annexes prescribing the Functional Chart, Organizational Structure and Staffing Pattern of the IMEG shall form part of this Resolution as "Annex A".


