**RESOLUTION NO. 2019-430**

**CONFIRMING THE AUTHORITY OF THE CHIEF, PNP TO FILL UP  
FOUR THOUSAND AND FOURTEEN (4,014) VACANCIES FOR  
POLICE INSPECTOR UNDER THE CALENDAR YEAR 2018  
LATERAL ENTRY PROGRAM FOR LINE OFFICERS**

**WHEREAS**, Section 14 (a) of Republic Act No. 6975, as amended by Section 5 of Republic Act No.8551, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

**WHEREAS**, the NAPOLCOM issued Memorandum Circular No. 2018-002, entitled: "Prescribing the Procedures and Guidelines in the Processing of Applicants for Appointments as Police Commissioned Officers via Lateral Entry";

**WHEREAS**, the Chief, PNP requested this Commission for authority to fill up a total of four thousand fourteen (4,014) vacancies for the rank Police Lieutenant under the CY 2018 Lateral Entry Program for Line Officers, which is aimed at strengthening the operational capabilities in National Operational Support Units (NOSUs) and Police Regional Offices (PROs);

**WHEREAS**, this Commission, after review of the PNP's CY 2018 Lateral Entry Program for Line Officers finds the same to be in order considering that the filling-up of such vacancies shall address the shortage of Police Commissioned Officers in the said NOSUs and PROs;

**NOW, THEREFORE**, the Commission, pursuant to its constitutional and statutory mandates, **HEREBY RESOLVES TO CONFIRM, AS IT HEREBY CONFIRMS**, the Distribution of the Four Thousand and Fourteen (4,014) Quota for Police Lieutenants Under the Calendar Year 2018 Lateral Entry Program for Line Officers, broken down as follows:


