RESOLUTION NO. 2019-707

**GRANTING THE CHIEF, PNP THE AUTHORITY TO RECRUIT TEN THOUSAND (10,000)
PATROLMEN AND PATROLOWOMEN (PAT) TO FILL UP THE CY 2019
REGULAR RECRUITMENT QUOTA**

WHEREAS, Section 14 (a) of Republic Act No. 6975, as amended by Section 5 of Republic Act No. 8551, provides that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, the Commission issued NAPOLCOM Memorandum Circular No. 2007-009, entitled: Prescribing the procedures and Guidelines for the recruitment, Selection and Appointment of PNP Uniformed Personnel and Termination of Service of Newly Appointed Police Officer 1 (PO1) While Still in Temporary Status;

WHEREAS, the NAPOLCOM issued Resolution No. 2018-119, entitled; "Approving the Restructuring of the PNP Mobile Forces which is aimed at standardizing and rationalizing further the distribution of the Public Safety Forces 9PSF0 to ensure maximum economy and efficiency in terms of manpower and materiel in meeting the challenges of the times;

WHEREAS, the Chief, PNP requested this Commission for authority to recruit ten thousand (10,000) Patrolmen and Patrolwomen to fill up the CY 2019 quota for regular recruitment, of which seven thousand eight hundred ninety-five (7, 895) shall be distributed to the PNP Mobile Forces in the Police Regional Offices (PROs) to address the insurgency problem in their areas of responsibility, while two thousand one hundred-five (2, 105) shall be allocated to selected National Support Units (NSUs) and other PNP Offices to support their personnel build-up programs;

WHEREAS, this Commission, after review of the PNP's CY 2019 Regular Recruitment Program for Patrolmen and Patrolwomen finds the same to be in order, considering that the distribution is based on police to population ratio, peace and order condition, and actual demands of the functional area;

NOW, THEREFORE, the Commission, pursuant to its constitutional and statutory mandates, HAS RESOLVED TO GRANT, AS IT HEREBY GRANTS, the Chief, PNP the authority to recruit ten thousand (10,000) Patrolmen and Patrolwomen under the PNP CY 2019 Regular Recruitment Program, distributed as follows:
