RESOLUTION No. 2022-0011

APPROVING THE DOWNGRADING OF THE CLASSIFICATION TYPE OF FIVE (5) MUNICIPAL POLICE STATIONS FROM TYPE "B" TO TYPE "C"

WHEREAS, Section 25 of the Republic Act No. 6975 provides the organization of the PNP in the national, regional, provincial, district offices and city/municipal police stations;

WHEREAS, the Commission issued Resolution No. 2005-140 which set new parameters for the classification of the Police Provincial Offices (PPOs), City Police Offices (CPOs) and Component City Police Stations (CCPSs) and Municipal Police Stations (MPSs) as the basis for categorization/classification due to population growth and increase/decrease of income of the Local Government Units (LGUs);

WHEREAS, the PNP submitted for consideration of the Commission the proposed downgrading of the classification type of several MPSs due to changes in population and lowering of income classification in certain localities;

WHEREAS, the Commission, after review of the abovementioned PNP proposal, finds the same in accordance with enacted laws which created additional municipalities that affected the demographic profiles of existing MPSs, and compliant with NAPOLCOM Resolution No. 2005-140;

NOW THEREFORE, the Commission, in the exercise of its constitutionally mandated authority to administer and control the PNP, **HEREBY RESOLVED TO APPROVE, AS IT HEREBY APPROVES**, the downgrading of the following five (5) Municipal Police Stations (MPSs) from Type "B" to Type "C":

RESOLVED FURTHER, that MPS shall be under the administrative supervision and operational control of their respective Provincial Directors, Provincial Police Office (PPO);


RESOLVED, FURTHERMORE, that MPS shall be headed by a Chief of Police (COP) with the rank of Police Major (PMAJ).
