RESOLUTION No. 2022-0184

AMENDING NAPOLCOM RESOLUTION NO. 2022-0010, ENTITLED: "APPROVING THE UPGRADING OF THE CLASSIFICATION TYPE OF TWENTY (20) COMPONENT CITY POLICE STATIONS AND ONE HUNDRED FIFTY-SEVEN (157) MUNICIPAL POLICE STATIONS, AND THE UPGRADING OF THE SIXTEEN (16) MUNICIPAL POLICE STATIONS TO COMPONENT CITY POLICE STATIONS"

WHEREAS, the Constitution and Republic Act No. 6975, as amended, provide that the National Police Commission (NAPOLCOM) shall exercise administrative control and operational supervision over the Philippine National Police (PNP);

WHEREAS, the Commission issued Resolution No. 2022-0010 which provides for the upgrading of the classification of type of several police stations;

WHEREAS, in the dissemination of NAPOLCOM Resolution No. 2022-0010, it was noted that were Municipal Police Stations (MPS) which were inadvertently placed under the jurisdiction of a different Police Provincial Office (PPO) and there were nomenclatures of certain MPSs which were unintentionally misspelled;

WHEREAS, there is a need to amend said issuance in order to clarify the jurisdiction of the PPOs;


NOW THEREFORE, the Commission, in the exercise of its constitutionally mandated authority to administer and control the PNP, **HEREBY RESOLVED, AS IT HEREBY RESOLVES**, to amend NAPOLCOM Resolution No. 2022-0010, specifically on the following Police Regional Offices:
