**RESOLUTION NO. 2019-011**

**AMENDING NAPOLCOM RESOLUTION NO. 2015-491, ENTITLED: “APPROVING THE ESTABLISHMENT AND ACTIVATION OF POLICE STRATEGY MANAGEMENT UNITS (PSMUS) IN ALL PNP UNITS/OFFICES FOR THE EFFECTIVE IMPLEMENTATION OF THE PNP P.A.T.R.O.L. PLAN 2030, OPLAN ‘LAMBAT-SIBAT’ AND OTHER PNP FLAGSHIP PROGRAMS”**

**WHEREAS**, the Commission issued NAPOLCOM Resolution No. 2015-491, entitled: *“Approving the Establishment and Activation of Police Strategy Management Units (PSMUs) in all PNP Units/Offices for the Effective Implementation of the PNP P.A.T.R.O.L. Plan 2030, Oplan ‘Lambat-Sibat’ and Other PNP Flagship Programs”*;

**WHEREAS**, the rationale for the establishment and activation of PSMUs in the different offices/units of the PNP is in view of the observation of the Commission during the cascading sessions that the Regional Police Strategy Management Units are not sufficient to adequately support, effectively monitor and address the requirements of the operational and tactical dashboards of the Police Provincial Offices and city/municipal police stations;

**WHEREAS**, it has come to the attention of the Commission that the activation of PSMUs in the different levels of command of the PNP has not been fully implemented in view of inadequacy in the number of personnel required to man said units;

**WHEREAS**, the Commission acknowledges that PNP personnel especially those assigned in the police stations, are the main operating arms of the PNP, but is also mindful of the importance of having PSMUs to monitor and evaluate the implementation of the different PNP Strategy Programs at the city/municipal levels;

**WHEREAS**, in view of the foregoing, the Commission deems it imperative to activate the PSMUs even up to provincial level only considering that such units are crucial in ensuring the achievement of the P.A.T.R.O.L. Plan 2030 and other flagship programs of the PNP;


**NOW, THEREFORE**, the Commission in the exercise of its Constitutional mandate to administer and control the PNP, **HAS RESOLVED TO AMEND, AS IT HEREBY AMENDS**, that the establishment and activation of the PSMUs as provided for under NAPOLCOM Resolution No. 2015-491 shall be up to provincial and highly urbanized city level only.


**RESOLVED, FURTHER**, that the PNP shall issue the necessary implementing guidelines for the establishment and activation of PSMUs at the provincial and highly urbanized city level.
