RESOLUTION NO. 2013-673

AMENDING NAPOLCOM RESOLUTION NO. 99-177 ENTITLED  
“APPROVING THE STANDARD SPECIFICATIONS AND DESIGN FOR PNP BIKE  
PATROL UNIFORM AND EQUIPMENT”

WHEREAS, Section 14 paragraphs (i) and (m), of Republic Act 6975 as amended by Section 5, paragraph (a), sub-paragraphs (5) and (8) of Republic Act 8551, empowers the Commission to “approve or modify plans and programs on education and training, logistical requirements, communications, records, information system, crime laboratory, crime prevention and crime reporting as well as prescribe minimum standards for arms, equipment and uniforms and, after consultation with the Philippine Heraldry Commission, for insignia of ranks, awards and medals of honor”;

WHEREAS, pursuant to the aforesaid legal prescription, the PNP, through its Uniform and Equipment Standardization Board (UESB) Resolution No. 2012-01 dated 28 February 2012, has recommended the proposed amendment to NAPOLCOM Resolution No. 99-177 dated November 17, 1999 entitled “Approving the Standard Specifications and Design for PNP Bike Patrol Uniform and Equipment” for consideration by the Commission;

WHEREAS, the amendment focuses on Paragraph III (T-shirt) of the NAPOLCOM Resolution No. 99-177, which prescribes the three (3) sets of t-shirt for use by PNP personnel assigned to the Bike Patrol, such as:

- a) Set A - blue gray with dark blue collar to be worn on Mondays, Wednesdays and Fridays;
- b) Set B - navy blue with dark blue collar to be worn on Tuesdays, Thursdays and Saturdays; and,
- c) Set C - white with dark blue collar to be worn on Sundays.

WHEREAS, the three (3) sets of the prescribed PNP Bike Patrol T-Shirt specification are to be replaced by the “PNP Patrol Shirt” specification under the concept of police patrol uniforms as provided for in NAPOLCOM Resolution No. 2009-717;

WHEREAS, there will be no changes on the markings and embroideries on the NAPOLCOM-approved PNP Patrol Shirt;

WHEREAS, the proposed amendment is not tailor-fit to any exclusive manufacturer of shirt garments available in the market;

WHEREAS, the Commission, upon thorough evaluation of the proposed amendment, finds the same to be in order, and in conformity with the requirements of Republic Act No. 6975, as amended by Republic Act No. 8551, its Implementing Rules and Regulations (IRR), and all existing policies and issuances of the Commission to meet the requirements of the PNP;

NOW, THEREFORE, the Commission in the exercise of its statutory powers to administer and control the PNP, RESOLVES TO AMEND, AS IT HEREBY AMENDS NAPOLCOM Resolution No. 99-177 entitled "Approving the Standard Specifications and Design for PNP Bike Patrol Uniform and Equipment" particularly on Para III (T-shirts) to be replaced by PNP Patrol Shirt.

BE IT RESOLVED FURTHER, that all other existing specifications which are inconsistent with the standard specifications and designs for the PNP Bike Patrol Uniform and Equipment for the use of PNP officers assigned to the PNP Bike Patrol are hereby CANCELLED.




