RESOLUTION NO. 2013-674

APPROVING THE MINIMUM STANDARD IN THE SPECIFICATIONS FOR
PNP TOURIST POLICE JACKET

WHEREAS, Section 14, paragraphs (i) and (m) of Republic Act No. 6975 as amended by Section 5, sub-paragraphs (5) and (8) of the Republic Act No. 8551 empowers the Commission to “approve or modify plans and programs on education and training, logistical requirements, communications, records, information system, crime laboratory, crime prevention and crime reporting as well as prescribe minimum standards for arms, equipment and uniforms and, after consultation with the Philippine Heraldry Commission, for insignia of ranks, awards and medals of honor”;

WHEREAS, pursuant to the aforecited legal prescription, the PNP, through its Uniform and Equipment Standardization Board (UESB) Resolution No. 2012-04 dated March 5, 2012, has favorably submitted and indorsed the proposed standard specifications for PNP Tourist Police Jacket for consideration of the Commission;

WHEREAS, the PNP Tourist Police Jacket is an essential gear to be used by PNP uniformed personnel assigned as Tourist Police when performing field duties and functions;

WHEREAS, the PNP UESB has certified that the standard specifications for PNP Tourist Police Jacket is not tailored fit to a particular brand in the market;

WHEREAS, after thorough review and evaluation, the Commission has determined that the PNP UESB proposed standard specifications for PNP Tourist Police Jacket conforms with the requirements of Republic Act No. 6975 as amended by RA No. 8551 and its Implementing Rules and Regulations (IRR), all existing policies and issuances of the Commission to meet the minimum standards in the specification for the logistical requirements of the PNP;

NOW THEREFORE, the Commission, in the exercise of its statutory powers to administer and control the PNP, HAS RESOLVED, AS IT HEREBY RESOLVES to approve the minimum standard in the specifications for PNP Tourist Police Jacket with modifications, to read as follows:

I. General Description:

A. MINIMUM STANDARDS IN THE SPECIFICATION:

On the right breast

- 3.3 Namecloth for Identification : Same material and color with the main fabric and the edging is dark blue
 - 3.3.1 Placement : At the right breast
 - 3.3.2 Content of namecloth : First layer: Embroidered FAMILY NAME, FIRST NAME INITIAL and MIDDLE INITIAL
Second layer: Embroidered RANK & BADGE NO.
 - 3.3.3 Color of thread : Yellow gold
 - 3.3.4 Font : Arial
 - 3.3.5 Placement of Rank and Badge Number : The rank and badge number are embroidered below the identification, the first letter of the rank should be aligned with the first letter of the family name and the last digit of the badge number should be aligned with the middle initial
 - 3.3.6 Alignment : The lower edge of the namecloth is in line with the lowest portion of the embroidered badge at the right breast.
- 4 Back View:
 - 4.1 Marking : Embroidered "TOURIST POLICE" marking at the upper back portion with name of the police personnel
 - 4.1.1 Color : Yellow gold thread
 - 4.1.2 Font : Arial
- 5 Supplier's/sewer's label : The name/trademark of the manufacturer/sewer and size of the jacket are embroidered on a polyester cloth and sewn inside at the back of the collar.

B. GUIDELINES ON THE PROPER WEARING:

- a) The PNP Tourist Police Jacket shall be worn by PNP uniformed personnel when performing field duties and functions as Tourist Police, particularly in cold areas.
- b) It should be worn with Tourist Police Uniform as approved under NAPOLCOM Resolution No. 2011-059 entitled, Amending NAPOLCOM Resolution Number 2006-181 on the Standard Specifications for Tourist Police Uniform.

C. LIMITATIONS ON THE USAGE OF THE PNP TOURIST POLICE JACKET:

- a) When PNP personnel is not on duty;
- b) Shall not be worn inside night clubs, cockpits, and other prohibited places;
- c) Shall not be worn by PNP personnel not assigned as Tourist Police;
- d) Shall not be worn by PNP personnel performing administrative duties; and
- e) Shall not be worn in any manner not prescribed hereof.

D. Must pass the PNP Test and Evaluation




