MEMORANDUM CIRCULAR NO. 2004-006

**PRESCRIBING THE SANCTION TO APPLICANTS
WHO ARE FOUND TO HAVE SUBMITTED SPURIOUS DOCUMENTS IN
THEIR APPLICATION FOR PNP EXAMINATION**

WHEREAS, pursuant to Section 21, R.A. 8551, amending Section 32 of R.A. 6975, *"The National Police Commission shall administer the entrance and promotional examinations for policeman on the basis of the standards set by the Commission"*.

WHEREAS, the Commission administers the police examinations and has consistently work to ensure its sanctity and integrity;

WHEREAS, it has been verified and confirmed that there are applicants who submit spurious documents in their application for PNP Entrance Examination;

WHEREAS, acts of misrepresentation are punishable under the following provisions of Section 6, Rule of the Civil Service Omnibus Rules, Implementing Book V of Executive Order No. 292, to wit;


"Provided that when applicant for examination is found to have intentionally made any false statement of any material fact in his application, or practices or attempts to practice or employ any deception or fraud in connection with his examination, the Commission shall invalidate such examination and such offenses shall be ground for his removal from the service: Provided, further, that if the applicant is not in the service, he shall be barred from taking any civil service examination and entry in government for a period to be determined by the Commission: Provided, finally, that: the Commission may, in its discretion, cause the filling of appropriate criminal charges pursuant to Section 67 of the Code."

WHEREAS, such anomalous acts violated the aforesaid applicants' own declaration that all information they supplied in their application are correct and true;


WHEREAS, the Commission finds the perpetuation of such anomalous act not only contrary to law but also personifies the propensity to commit similar acts that are contrary to the high standard of ethics in public service, particularly in the police service;


NOW THEREFORE, the Commission in its exercise of its mandate to administer the entrance and promotional examinations for policeman, and mindful of the need to further ensure the high quality of personnel entering the police service, **HAS RESOLVED, AS IT IS HEREBY RESOLVED**, that applicants who are found to have submitted spurious documents in their applications for PNP Examination shall be barred **PERMANENTLY** from taking any police service examination. In the event that these anomalous acts are committed by personnel in the active service, he / she shall be charged with dishonesty and be meted the penalty of dismissal from the service.
