**MEMORANDUM CIRCULAR NO. 2008 - 17**

**AMENDING NAPOLCOM MEMORANDUM CIRCULAR NUMBER 2007-004  
BY RECONSTITUTING THE SENIOR OFFICERS PLACEMENT AND PROMOTION  
BOARD (SOPPB) COMMITTEES "ALPHA" AND "BRAVO"**

**WHEREAS**, the Commission issued Memorandum Circular No. 2007-004 dated May 28, 2007 entitled *Amending Napolcom Memorandum Circular No. 2007-004 by Reducing the Number of Committees that will Assist the Senior Officers Placement and Promotion Board (SOPPB) in Drawing Up the List of Eligibles into Two (2) Committees*;

**WHEREAS**, the SOPPB, thru the Chief, PNP requested for consideration of the Commission the reconstitution of the SOPPB Committees "Alpha" and "Bravo";

**WHEREAS**, the reconstitution on the composition of Committee "Alpha" shall involve the switch of committee designations between The Chief, Directorial Staff (TCDS) and The Director, Personnel and Records Management (TDPRM), and the substitution of the committee membership from Deputy Directors to the Directors of the same Directorial Staffs, except for the Director, Legal Service (DLS) who shall remain as regular member;

**WHEREAS**, the reconstitution on the composition of Committee "Bravo" shall involve the switch of committee designations between The Director, Human Resource and Doctrine Development (TDHRDD) and The Director, Investigation and Detective Management (TDIDM), and that the committee designations of Deputy Directors of the Directorial Staffs as regular members shall remain;

**WHEREAS**, the amendment on the composition of Committees "Alpha" and "Bravo", as indicated herein, is aimed at enhancing the selection process and deliberation of senior PCOs eligible to star rank positions and other key positions in the PNP;

**WHEREAS**, after review of the PNP's proposal, the Commission finds the same to be in order;

**NOW THEREFORE**, the Commission, pursuant to its constitutional mandate to administer and control the PNP, **HAS RESOLVED TO AMEND, AS IT HEREBY AMENDS**, Napolcom Memorandum Circular Number 2007-004 by Reconstituting The Senior Officers Placement and Promotion Board (SOPPB) Committees "Alpha" And "Bravo", to wit:


