**MEMORANDUM CIRCULAR NO. 2012-001**

**FURTHER AMENDING THE SCHEDULE OF FEES TO BE GRANTED TO  
NAPOLCOM SCHOLARS OR GRANTEES BY VIRTUE OF REPUBLIC ACT 6963,  
AMENDING FOR THIS PURPOSE MEMORANDUM CIRCULAR NO. 2005-001.**

**WHEREAS**, NAPOLCOM Memorandum Circular No. 95-011 dated, May 25, 1995 prescribes the rules and regulations governing the implementation of the NAPOLCOM Scholarship Program for surviving children of deceased and/or permanently incapacitated PNP personnel, including the schedule of tuition and miscellaneous fees, pursuant to Republic Act No. 6963

**WHEREAS**, Memorandum Circular No. 98-06 was issued on February 26, 1998 decentralizing the implementation of the Program to the Commission's regional offices, and integrating as well as increasing the scholarship benefits for the payment of the tuition and miscellaneous fees of each scholar.

**WHEREAS**, the Commission, after realizing the steady decrease in the remittance of funds from the PNP that would affect the implementation of the Scholarship Program, has adopted NAPOLCOM Memorandum Circular No. 2005-001, amending NAPOLCOM Circular No. 1998-011, which adjusted the schedule of scholarship benefits as a measure to sustain the said program;


**WHEREAS**, in order to cope with the continued inflationary costs of tuition and miscellaneous school expenses prescribed by the different institutions of learning, the Commission finds it necessary to increase the scholarship benefits to its grantees/scholars;

**NOW, THEREFORE**, this Commission, as Administrator of the Scholarship Program for surviving children of deceased and/or permanently incapacitated PNP members pursuant to Republic Act No. 6963, **HAS RESOLVED TO REVISE, AS IT HEREBY REVISES**, the schedule of fees to be granted to NAPOLCOM scholars, amending for this purpose Section 1 of NAPOLCOM Memorandum Circular No. 2005-001, to read as follows:

Award of financial scholarship benefits for tuition fees and miscellaneous expenses to a NAPOLCOM Scholar shall be paid directly to the school in which he/she is enrolled or reimbursed to the said scholar by this Commission upon presentation of his/her approved enrollment or registration form and official receipt of payment which shall not exceed the following amounts:

1. P12,000 for elementary scholar per school year
2. P16,000 for high school scholar per school year
3. P12,000 for vocational scholar per semester
4. P 22,000 for college scholar per semester
