

MEMORANDUM CIRCULAR 95-01

**ESTABLISHING THE AWARDS SYSTEM FOR THE
CLEANEST AND GREENEST UNITS OF THE
PHILIPPINE NATIONAL POLICE**

WHEREAS, the National Police Commission issued a Memorandum to C, PNP on 26 July 1994 enjoining their support and cooperation to the Clean and Green Program of the National leadership;

WHEREAS, the Awards to the Cleanest and Greenest Unit of the PNP is an effective mechanism for inculcating in the minds of the PNP members the Filipino values of cooperation, discipline, resourcefulness, self-reliance, cleanliness and environmental awareness;

WHEREAS, there is a need to formally establish the PNP Awards for the cleanest and greenest unit;

NOW, THEREFORE, the Commission in the exercise of its power of administrative control and supervision over the PNP, do hereby direct the following:

1. Creation of the Awards

The following PNP Awards are hereby created:

- Cleanest and Greenest PNP Regional Office
- Cleanest and Greenest PNP Provincial Command
- Cleanest and Greenest City Police Station
- Cleanest and Greenest Municipal Police Station

2. Creation of Search Committee

At the national level, the Committee on the Search for the Cleanest and Greenest Unit is composed of the following:

Deputy Chief for Administration	- Chairman
Director for Plans	- Member
Director for Logistics	- Member
Director for Operations	- Member
Inspector General	- Member

At the regional level, a Search Committee shall be created to determine the awards for provincial levels and below. Thereafter there will be competition at the national level. The Regional Search Committee shall be composed of the following:

Regional Director	- Chairman
Dep. Dir. for Administration	- Member
Chief Regional Inspectorate	- Member
Asst. Reg'l Dir. for Opns & Plans	- Member
Asst. Reg'l Dir. for Logistics and Research and Development	- Member

3. Awards and Prizes

The annual PNP Awards shall be conferred to each national awardee as indicated in Section 1 hereof in the form of Trophy and Cash Prize of not less than P10,000 to be sourced from the annual savings of the PNP.

4. Effectivity

This memorandum shall take effect immediately. Done at Makati, Metro Manila on the 11th day of January 1995.
