MEMORANDUM CIRCULAR NO. 95-09

AMENDING NUMBER 7(a) OF NAPOLCOM MEMORANDUM CIRCULAR NO. 95-04 DATED JANUARY 12, 1995, ENTITLED "GUIDELINES AND PROCEDURES GOVERNING THE SELECTION AND PLACEMENT OF POLICE COMMISSIONED OFFICERS TO KEY POSITIONS IN THE PNP".

WHEREAS, Memorandum Circular No. 95-04 dated January 12, 1995, enunciated the policy of the Commission of promoting professionalism in the police service through the institution of merit and fitness as the primary consideration in the selection and placement of officers to key positions in the organization;

WHEREAS, to implement and institutionalize this avowed policy, number 7(a) of the above-mentioned Circular created a PNP Selection and Placement Board, composed of nine (9) members, one of whom is the Director, Intelligence Command;

WHEREAS, the Chief, PNP in a Memorandum dated February 24, 1995, manifested that the Director for Intelligence, and not the Director of the Intelligence Command, should be the member of said Board, since it is the former who "assist the Chief, PNP on matters concerning intelligence and as such has all the necessary access, maximum coverage and capability to prepare and supervise intelligence policies, plans and programs", while the latter, "is the intelligence operating arm of the PNP under the functional supervision of the DI";

WHEREAS, finding merit on the above observations and recommendation of the Chief, PNP, an amendment of the composition of the PNP Selection and Placement Board is in order;

NOW, THEREFORE, this Commission, in the exercise of its constitutionally mandated authority of administrative supervision and control over the PNP, RESOLVES, as it does HEREBY RESOLVED, to amend number 7(a) of Napolcom memorandum Circular No. 95-04, to read as follows:

"7. Creation of the PNP Selection and Placement Board:


- a. There is hereby created a PNP Selection and Placement Board, composed of the following:


Chairman : Deputy Chief for Administration
Vice-Chairman: The Chief of Directorial Staff


Members : Director for Personnel

PNP"


This Circular takes effect immediately.


