



MEMORANDUM CIRCULAR NO. 96-007

AMENDING SECTION 14 OF NAPOLCOM MEMORANDUM CIRCULAR NO. 95-011, ON THE SUBJECT "PRESCRIBING THE RULES AND REGULATIONS IN THE IMPLEMENTATION OF THE NAPOLCOM SCHOLARSHIP PROGRAM FOR SURVIVING CHILDREN OF DECEASED AND/OR PERMANENTLY INCAPACITATED PNP PERSONNEL UNDER RA 6975 AND NAPOLCOM RESOLUTION NO. 94-047

WHEREAS, under Section 14 of Napolcom Memorandum Circular No. 95-011 dated May 25, 1995, it is directed that tuition and miscellaneous fees of a Napolcom scholar shall be paid by the Commission directly to the school concerned upon submission of the required documents;

WHEREAS, it is viewed that a strict implementation of this requirement while assuring a safeguard in the disbursement of public funds, appears impractical and would further inconvenience the concerned Napolcom scholar considering that most educational institutions require, as a matter of policy, not only the payment of reservation fee, but also a partial payment of the tuition fee immediately upon enrollment to guarantee his admission, not to mention the practice of other schools of requiring full payment upon enrollment;


WHEREAS, mindful of the beneficial intent of the law, there is urgent need to amend the Napolcom issuance to conform with existing school policies on the matter;

NOW, THEREFORE, this Commission as Administrator of the Scholarship Program for surviving children of deceased and/or permanently incapacitated PNP personnel, hereby amends Section 14 (a) of Napolcom Memorandum Circular No. 95-011, to read as follows:


- "a. The grantee should submit to the Napolcom the school bills and confirmation of subjects to which the grantee is enrolled duly signed by the authorized school official immediately after assessment to facilitate the release of payment directly to the school concerned, Provided however, that if the school to which the grantee is to be enrolled, requires as a matter of policy for admission, the payment of reservation fee or partial payment or full payment, as the case may be, payment thereof shall be made by the grantee, subject to reimbursement by this Commission according to the schedule of fees under Section 12 of the Circular upon submission of documents in support of the same, and Provided finally, that the balance, if any, shall be paid directly to the school concerned."

This Circular shall take effect immediately.




