MEMORANDUM CIRCULAR NO. 98-011

FURTHER AMENDING SECTION 2 OF NAPOLCOM MEMORANDUM CIRCULAR NO. 98-06 DATED FEBRUARY 26, 1998, ENTITLED "AMENDING RESOLUTION NO. 94-047 DATED DECEMBER 14, 1994 AND MEMORANDUM CIRCULAR NO. 95-11 DATED MAY 25, 1995 WHICH ESTABLISHED THE NAPOLCOM SCHOLARSHIP PROGRAM FOR SURVIVING CHILDREN OF POLICE PERSONNEL AND PRESCRIBED THE RULES AND REGULATIONS IN THE IMPLEMENTATION THEREOF"

WHEREAS, Section 2 of Napolcom Memorandum Circular No. 98-06 increased the financial assistance (tuition fees and miscellaneous expenses), and at the same time, enjoined that payment thereof shall be made on lump sum basis directly to Napolcom scholars;

WHEREAS, Section 8 of RA No. 6963 states that "All surviving children of the deceased or permanently incapacitated police or military personnel or fireman shall be extended scholarship up to college in a non-exclusive institution, subject to the policies on the tuition of said institution. The scholarship privilege shall be limited to the payment of tuition and miscellaneous fees payable to the school to be remitted by the National Police Commission or the Department of National Defense, as the case may be, upon presentation to it of the approved enrollment or registration form." (Underlining Supplied)

WHEREAS, in order to conform with the express mandate of the law, it is imperative that Section 2 of Napolcom Memorandum Circular No. 98-06 be amended accordingly;

NOW THEREFORE, this Commission, pursuant to the provisions of RA No. 6963, resolves to amend, as it hereby amends Section 2 of Napolcom Memorandum Circular No. 98-06, to read as follows:

"Section 2. - Section 12 of Napolcom Memorandum Circular No. 95-011 s. 1995 is hereby amended to read as follows:

Sec. 12. Granting of financial scholarship grant for tuition fees and miscellaneous expenses to which a Napolcom scholar is entitled to shall be made payable directly to the school to which he is enrolled by this Commission upon presentation by the grantee of his approved enrollment or registration form which shall not exceed the following amounts:

1. P 9,000.00 for elementary scholar per school year
2. P12,000.00 for high school scholar per school year
3. P10,000.00 for vocational scholar per school year
4. P15,000.00 for college scholar per semester.
