MEMORANDUM CIRCULAR NO. 99-003

REORGANIZING THE PHILIPPINE NATIONAL POLICE (PNP) SENIOR OFFICERS PLACEMENT AND PROMOTION BOARD (SOPPB), FURTHER AMENDING FOR THIS PURPOSE NAPOLCOM MEMORANDUM CIRCULAR NO. 95-04, AS AMENDED, BY MEMORANDUM CIRCULARS NOS. 95-015, 95-020, 95-027, AND 98-08.

WHEREAS, under NAPOLCOM Memorandum Circular No. 98-08, dated February 26, 1998, the PNP Senior Officers Placement and Promotion Board (SOPPB) is composed of seventeen (17) senior officers who are occupying key positions in the PNP organization, inclusive of DCA as Chairman and DCO as Vice-Chairman;

WHEREAS, the SOPPB has been established primarily to serve as an advisory body to the Chief, PNP on all matters pertaining to selection and placement of police commissioned officers to key positions in the PNP;

WHEREAS, considering the nature of police work, designation, assignments, reassignments and promotion of PNP officers always need expeditious action;

WHEREAS, the present membership of SOPPB composed of seventeen (17) senior police officers is quite unwieldy and difficult to convene within short notice;

WHEREAS, in order to facilitate action in the selection and placement processes, there is a need to reduce the membership of SOPPB to a manageable number;

NOW, therefore, this Commission in the exercise of its constitutionally mandated administration and control functions over the PNP, hereby orders and directs:

Section 1. **Reorganization of the SOPPB**. The Senior Officers Placement and Promotion Board(SOPPB) is hereby reconstituted and henceforth shall be composed of one (1) senior police officer as Chairman and six (6) senior police officers as members, who shall all be designated by the Chief, PNP, subject to the confirmation or approval by the Commission;

Section 2. **Reglementary Period to Constitute the new SOPPB**. Within ten (10) days from the effectivity of this Memorandum Circular, the Chief, PNP shall issue the Order constituting the new SOPPB and submit a copy thereof to this Commission for confirmation or approval.

Section 3. **Functions of the SOPPB**. The newly reconstituted SOPPB shall perform the same functions as provided under Memorandum Circular No. 95-04, as amended.


Section 4. **Repealing Clause.** All rules and regulations and other issuances, or portions thereof, inconsistent with this Memorandum Circular are hereby repealed or modified accordingly.

Section 4. **Effectivity.** This Memorandum Circular shall take effect immediately.
