**WHEREAS**, a Memorandum of Agreement, dated May 1998, was signed by and between the National Police Commission and the Bases Conversion and Development Authority which among others delivered to NAPOLCOM 2,250 housing units at Pamayanang Diego Silang (PDS) Village in Taguig City, Metro Manila for the benefit of NAPOLCOM and PNP personnel;

**WHEREAS**, pursuant to DILG Office Order No. 94-20, dated October 18, 1994, the NAPOLCOM Housing Board is mandated to submit to the Commission the approval/disapproval of all legal actions and/or recommendations involving the award of housing units to deserving NAPOLCOM and PNP personnel;

**WHEREAS**, an invitation was published for qualified NAPOLCOM personnel to apply for housing units at PDS subject the usual rules and regulations;

**WHEREAS**, about thirty (30) personnel applied for the award of housing units;

**WHEREAS**, after review and evaluation, four (4) personnel qualified for the five (5) vacant MC units, while eighteen (18) qualified for the six (6) vacant MB units at the NAPOLCOM Housing Project;

**WHEREAS**, on December 19, 2006 a raffle draw was held at the NAPOLCOM Multi-Purpose Hall to determine the awardees from the excess number of applicants;

**WHEREAS**, the NAPOLCOM Housing Board has recommended the award of the aforesaid vacant housing units to the personnel who drew the winning numbers in the raffle;

**NOW, THEREFORE**, the Commission **RESOLVES TO APPROVE, AS IT HEREBY APPROVES**, the award of four (4) Model "C" units and six (6) Model "B" units at Pamayanang Diego Silang Village, Taguig City to the following NAPOLCOM personnel, namely:




